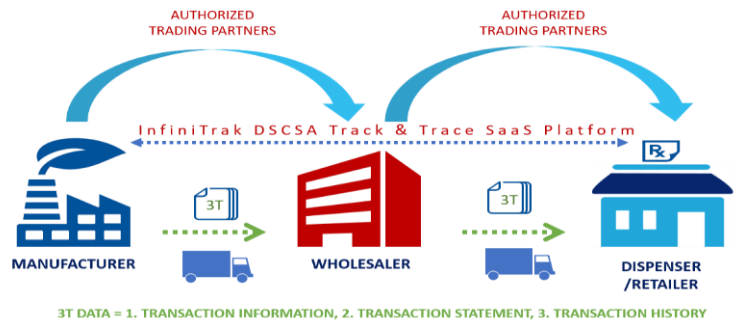


Serialization is one of the first steps towards making every capsule, vial, tablet or strip traceable through the pharmaceutical supply chain. Manufacturers are required to affix 2D Bar Codes and wholesalers will only be able to transact serialized

products after November 27, 2019. Furthermore, Dispensers will only be able to transact serialized products after November 2020 with exceptions for exempt and grandfathered products.

The product identifier is a GS-1 compliant standardized graphic that includes, in both human-readable form and on a machine-readable data carrier:

- The standardized numerical identifier (composed of the National Drug Code combined with a unique alphanumeric serial number),
- Lot number, and
- Expiration date of the product

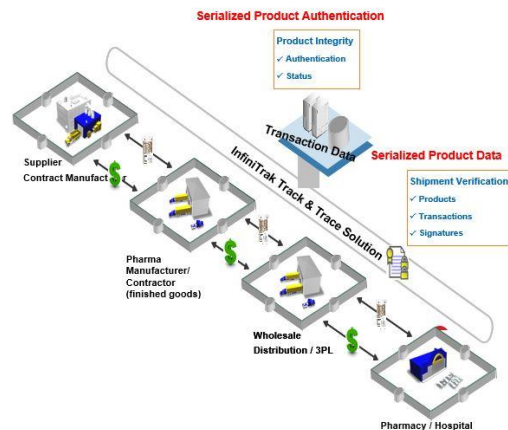

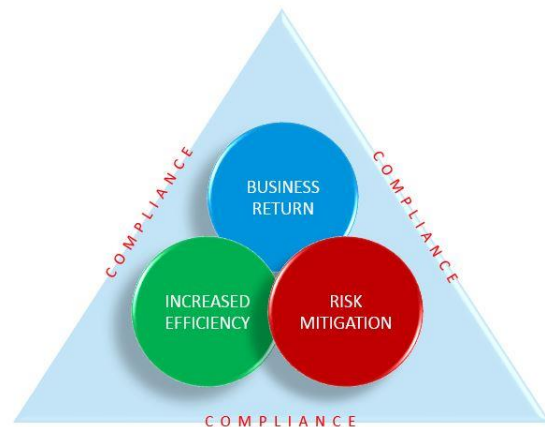
