### **CALL TO ORDER**

Trustee Starner, Vice Chairman, called the meeting to order at 5 P.M.

Vice Chairman Starner welcomed attendees and reviewed the evening's agenda, which would include the administration of the Oath of Office and an Executive Session to discuss collective bargaining issues.

### **OATH OF OFFICE**

Vice Chairman Starner administered the Oath of Office to the new Caucus of School Board Presidents appointed trustees:


Voting No: None.

The Executive Session concluded at 6:45 P.M.


## ADJOURNMENT
