POSITION SUMMARY

The position of speech pathologist (adult) is responsible for the provision of assessment and therapy services in an area of clinical expertise requiring special knowledge and depth of experience. The position is able to work independently whilst at the same time contributing strongly to the multidisciplinary healthcare team, and is expected to initiate and participate in teaching, training, research and quality activities. The position will also be expected to represent their program and discipline as delegated by their line manager.

The position aims to provide evidence based, high quality, safe, patient/client centred care that meets current professional best practice standards.

In future, this role will move to fee-for service model.

POSITION RESPONSIBLITIES

Inspiro has as a principle part of its philosophy, an emphasis on illness prevention, early intervention and health promotion. To achieve this, this role will work co-operatively within a team of dedicated professionals, to provide high quality, comprehensive and multi-disciplinary health services.

Clinical Service Delivery

- Provide a "person centred" model of care that focuses on the individual's needs and circumstances of the client
- Complete complex assessments using both dynamic assessments and a range of assessment tools/frameworks according to professional standards.
- Develop and implement a complex treatment/intervention plan based on clinical assessment, client centred goals and evidence based practice.
- Complete all documentation in a timely and accurate manner in accordance with the organisational standards.
- Demonstrate and foster good understanding of professional values and ethics in clinical work.
- Demonstrate effective communication skills with the multidisciplinary team in both formal and informal settings.
- Demonstrate effective communication and rapport building skills with patients/clients, carers and community agencies.
- Demonstrate clarity in written skills.
- Document clear treatment goals and management plans in the patient Health Record.
- Demonstrate effective communication in providing formal and informal feedback to clients .
- Demonstrate the ability to write reports for the NDIS, being able to convey assessment results in a clear and easy to understand format for readers who are not familiar with speech pathology specific terminology.
- Demonstrate a good understanding of best practice assessment and intervention for augmentative and alternative communication, language and social pragmatics across the life span.
- Demonstrate an ability to provide assessment and management of clients presenting with dysphagia.

Teamwork, Quality Improvement and Professional Development

- Participate in team and service planning and evaluation, health promotion activities, policy development and other project activities as required.
- Actively participate in Inspiro's continual quality improvement program including the development of new practice models and documentation audits.

- Be committed to ongoing professional development and undertake annual mandatory training.
- Keep up to date with developments and trends within Community Health, Aged and Disability service provision.
- Ensure Inspiro's services are accessible, client focused; developed, delivered and evaluated in partnership with our diverse communities.
- Report any adverse outcome or near miss experienced by the client so that strategies can be implemented to prevent recurrence occurring to any client wherever possible
- Support and value diversity at all levels within the organisation and in all services that we provide by being respectful and appreciating individuals' emotional, intellectual, physical, spiritual and experiential differences and uniqueness.

- Demonstrated ability to assess and implement therapy for individuals whose goals relate to social skills improvement.
- High level communication skills, both written and oral.
- Demonstrated capacity to work in a multidisciplinary team.
- Demonstrated ability to introduce innovative clinical practice.
- Commitment to improving own skills and undertaking quality and research activities.
- Demonstrated understanding of professional codes of conduct.
- Excellent time management skills.
- Ability to efficiently and independently manage and prioritise a complex clinical workload.
- Current Victorian Driver's Licence and the ability to drive a range of vehicles as required
- Current Working with Children's Check valid for employment purposes.
