INCOME RANGE

Which income range are you in?

Low income range	 People receiving a full or part pension. People with a Health Care card. Single people with a before-tax income of under \$35,299. Couples with a before-tax income of under \$54,007. Families with one child with a before-tax income of under \$59,884 (plus \$5,877 for each extra dependent child). Any of the above who face additional costs (due to disability and/or other factors) which reduces their income to this level.
Medium income range	 Single people with a before-tax income greater than \$35,299 but less than \$77,668. Couples with a before-tax income greater than \$54,007 but less than \$103,830. Families with one child with a before-tax income greater than \$59,884 but less than \$109,342 (plus \$5,877 for each extra dependent child.) Any of the above who face additional costs (due to disability and/or other factors) which reduces their income to this level.
High income range	 Single people with a before-tax income of more than \$77,668. Couples with a before-tax income of more than \$103,830. Families with one child with a before-tax income of more than \$109,342 (plus \$5,877 for each extra dependent child).
