## Ministry of Economy and Innovation financial help program

The industry 4.0 audit program aims to encourage Quebec manufacturing companies to undertake the digital shift, by carrying out a diagnosis and an industry 4.0 digital plan.

## Eligible financial assistance

The financial assistance granted to the organization consists in a non-refundable contribution of up to \$15 000.

## **Eligible Clientele**

- > For-profit companies in the manufacturing sector with establishments in Quebec.
- > Cooperatives and social economy enterprises conducting commercial activities in the manufacturing sector.

#### Prerequisites

The company wishing to avail itself of an industry 4.0 audit must have previously carried out **strategic planning** defining at least its mission, its vision, its strategic objectives and its operational issues.

## Eligible projects

Projects related to conducting an industry 4.0 audit consist to:

- > analyze and assessing, using a diagnostic tool, the level of maturity of the company wishing to undergo the Digital Transformation;.
- > produce a report including a diagnosis, an assessment of the company's digital maturity, as well as a personalized digital plan
- adapted to the organizational and financial reality of the company.

#### Send the request

Applications must be submitted online, unless otherwise directed by the Ministry.

To access the service for the first time, your company must have a **clicSÉQUR – Entreprises account** and be registered for the services offered by the Ministry. Some delays are to be expected to process applications.
