





2019 Judicial Hellholes®





- AIG is watching the evolving developments in the tort environment, with the expanding impact of "social issues and social inflation." -AIG
- Recent loss trends are "surprisingly high," particularly in liability lines...Jury awards are rising and medical and social inflation is higher – Liberty Mutual
- "...as we look at the more recent data coming in subsequent to the second quarter, we continue to see loss activity that is coming in hotter than we would have expected. And that's after the higher level of expectation we had after the fourth quarter and the second quarter. ... so we respond with both price and litigation claims handling strategies." - Alan Schnitzer, Travelers CEO, September 2019



2nd Quarter Pricing Insurer Commentary

- "... increased loss frequency and severity in a number of long-tail business lines are starting to squeeze carriers' margins as social inflation appears to be driving loss cost trends higher. This is significant because the casualty market has been the main catalyst of nearly all past market turns and it comes at a time of diminishing reserve redundancies." – Guy Carpenter, 2019 Changing Nature of Risk
- General liability is likely the next commercial segment to harden W.R. Berkley
- In major accounts and specialty commercial... Renewal price change for major accounts was 8.5% ...excess casualty up almost 10%. ...Turning to our middle market and small commercial business, premiums overall were up over 4.5%. Middle market pricing for primary casualty was up 4.5%; excess umbrella up over 6% *Chubb*






