

Payor and Health Plan Telehealth Guidance

Overview

- Effective March 6, 2020, and for the duration of the COVID-19 Public Health Emergency, Medicare will be loosening guidelines for practices to receive payment for telehealth services.
- This document provides detail on the latest billing guidelines released from Medicare and from commercial insurers. We remain committed to providing you with the most up-to-date information and will notify your practice of any changes to information included in this guide.

Notable modifications to telehealth billing due to COVID-19

- Telehealth visits are considered the same as in-person visits and reimbursed at regular rates.
- Patient's originating-site location expanded to any healthcare facility as well as patient's home.
 - Care providers will be able to bill for telehealth services performed while a patient is at home.
- Prior authorization requirements for patient eligibility have been lifted.
- Copays for patients are waived until further notice.

87635	Infectious agent detection by nucleic acid (DNA or RNA); severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) (coronavirus disease [COVID-19]), amplified probe technique

COVID-19-related Diagnosis Codes

Below are a few existing ICD-10 Codes that providers can bill:

- B97.29 – Confirmed cases: Other coronavirus as the cause of diseases classified elsewhere
- B97.21 – SARS-associated coronavirus as the cause of diseases classified elsewhere
- Z20.828 – Contact with and (suspected) exposure to other viral communicable diseases
- Z03.818 – Exposure to COVID-19 and the virus is ruled out after evaluation
- For unconfirmed: providers can bill signs and symptoms of coronavirus, which according to the CDC are:
 - Fever, unspecified – R50.9
 - Cough – R05
 - Shortness of breath – R06.02
 - Any other diagnosis the provider deems pertinent to the patient’s presenting symptomology

G2012	Brief communication technology-based service, e.g., virtual check-in by a physician or other qualified health care professional who can report evaluation and management services provided to an established patient, not originating from a related E/M service provided within the previous seven days nor leading to an E/M service or procedure within the next 24 hours or soonest available appointment; 5-10 minutes of medical discussion
0188T	Remote real-time interactive videoconferenced critical care, evaluation and management of the critically ill or critically injured patient; first 30-74 minutes
G0406	Follow-up inpatient consultation, limited; physicians typically spend 15 minutes communicating with the patient via telehealth or just "Inpt/tele follow up 15" for short, used in Consultation
G0425	Telehealth consultation, emergency department or initial inpatient, typically 30 minutes communicating with the patient via telehealth or just "Inpt/ed teleconsult 30" for short, used in Consultation.
G0459	Inpatient telehealth pharmacologic management, including prescription, use and review of medication with no more than minimal medical psychotherapy or just "Telehealth inpt pharm mgmt" for short, used in Medical Care.
G0508	Telehealth consultation, critical care, initial; physicians typically spend 60 minutes communicating with the patient and providers via telehealth or just "Crit care telehea consult 60" for short, used in Medical Care.
Q3014	Telehealth originating site facility fee
S9110	Telemonitoring of patient in their home, including all necessary equipment; computer system, connections, and software; maintenance; patient education and support; per month or just "Telemonitoring/home per mnth" for short, used in Other Medical Items or Services.
T1014	Telehealth transmission, per minute, professional services bill separately or just "Telehealth transmit, per min" for short, used in Other Medical Items or Services.
