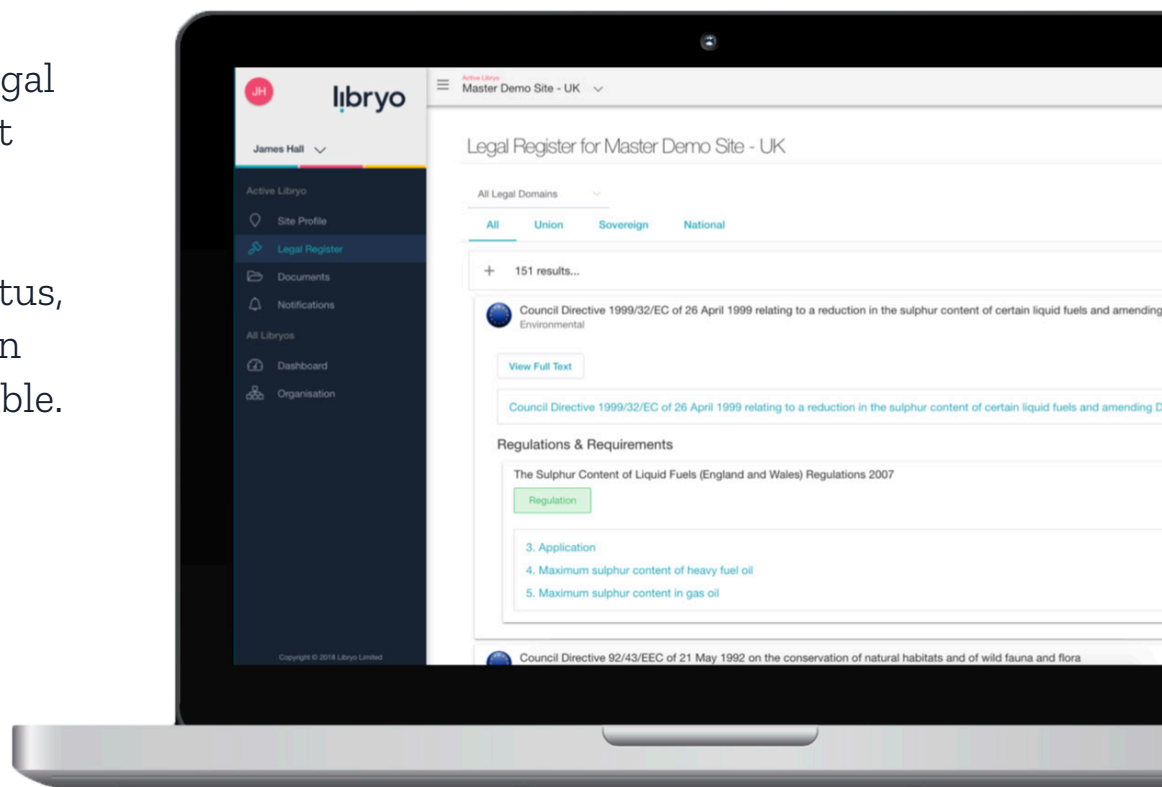
Knowing the legal obligations that suppliers face, let alone their compliance status, has to date been largely impossible.

Libryo's technology transforms regulations into a globally standardised, machine readable format which is constantly updated.

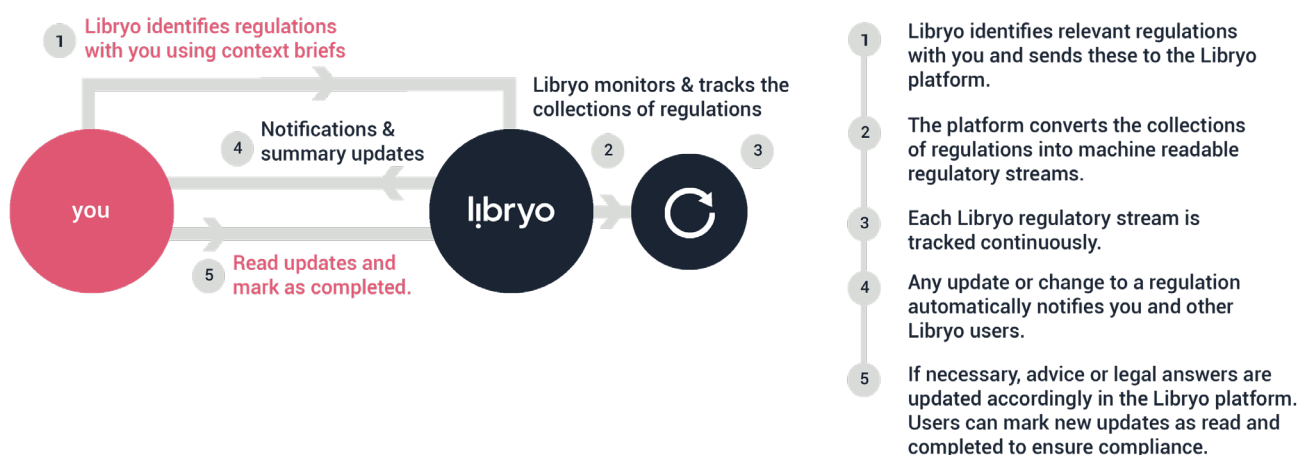
End-to-end compliance status certainty and transparency is now possible.

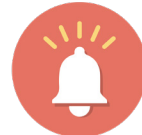
## Self-assessment tools
