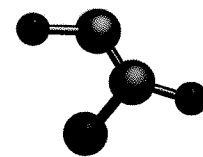

# QUANTAVENE™ 500 CONCENTRATE

## Description

A proprietary blend of organic acids and copper propionate to clean stains caused by algae on greenhouse floors, benches, walkways, capillary matting, cooling pads and walls.

## Ingredients

Ammonium Propionate, Propionic Acid, Water, Copper Propionate, Lemon Oil Terpenes, Benzoic Acid and Sorbic Acid.

## Directions

READ ENTIRE LABEL – USE IN ACCORDANCE WITH LABEL INSTRUCTIONS.

THIS PRODUCT IS A CONCENTRATE AND MUST BE DILUTED BEFORE USING.

Use dilution immediately – Do not store diluted solution. Do not mix with bleach or any other strong oxidizing agents.

Pressure wash surface to be cleaned. Dilute Quantavene at 4.3-6.4 fluid ounces per 1 gallon of clean water. Apply diluted Quantavene solution until runoff. Allow to dry before irrigation. Initially apply weekly for at least three weeks or until stains are removed, whichever is longer, and monthly thereafter.

## Storage

STORAGE AND DISPOSAL: Do not contaminate water or food by storage and disposal. Store in a well-ventilated, cool, dry place (20 – 25 °C). Do not freeze. Shelf life is 12 months unopened under proper storage conditions. Keep container closed when not in use. CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container. Offer for recycling if available or reconditioning if appropriate or puncture and dispose of in a sanitary landfill, or by incineration.

PRECAUTIONARY STATEMENTS: WARNING. Do not breathe the mist or vapor. Wash thoroughly after handling. Do not eat, drink or smoke when using this product.

Use only outdoors or in a well-ventilated area. Wear protective gloves/protective clothing/eye protection/face protection.
