

Terms & Conditions

Gallagher Toowoomba - June Jacket Giveaway

- 1. The promoter is: Arthur J. Gallagher & Co (AUS) Limited ABN 34 005 543 920 (AFSL 238312).
- 2. To enter the promotion, entrants must either be over the age of 18 or a legal entity (if the entrant is not an individual), and must purchase a new eligible insurance policy, brokered by the promoter's Toowoomba branch, that is incepted between 1 June 2017 and 29 June 2018 ("eligible entrant").
- 3. The promotor's Toowoomba branch is located at 118 Campbell St, Toowoomba City QLD 4350 and the branch can be contacted at (07) 4639 7111.
- 4. The eligible insurance policies must be annual policies of the following:
 - Farm Insurance Packages
 - o Business Insurance Packages from the promoter's preferred insurer panel
- 5. For clarity, ineligible insurance policies which do not attract a prize include:
 - Crop Insurance
 - House and Contents Insurance
 - Private Motor Vehicle Insurance
 - Short term insurance policies (i.e. not annual policies)
 - Renewal and transfer of insurance policies.
- 6. The prize will be one promoter branded brown Burke & Wills ¾ Riding Jacket (oilskin). The prize has a retail value of \$119.00 (AUD).
- 7. Each eligible entrant will receive only one prize, regardless of the number of insurance policies brokered by the promotor, and/or regardless of the number of policy holders.
- 8. No cash alternative to the prizes will be offered. Prizes are not transferable.
- 9. The closing date for entry will be Friday 29 June 2018 at 17:00 AEST.
- 10. The promotor will notify the entrant by the closing date, whether the entrant is eligible for a prize and how to claim the prize. To claim the prize, eligible entrants must provide the size and delivery address to the promotor within 14 days of notification.
- 11. The promoter will deliver the prize to the delivery address and in the size provided by the eligible entrant within 28 days of:
 - o For annual payments: when the full premium and full broker fee is paid by the eligible entrant;
 - For monthly instalments: when the first instalment and full broker fee is paid by the eligible entrant;
 - For premium funding: when the premium funding contract is accepted by the premium funder and the first instalment and full broker fee is paid on behalf of the eligible entrant;
- 12. If the prize is out of stock or a size is not available, the promotor will deliver the prize within such other reasonable time as agreed to between the promotor and eligible entrant.
- 13. If the eligible entrant has not provided a size and delivery address to the promotor within 14 days of notification, the promotor will notify the eligible entrant that it will keep the prize for the eligible entrant at the promoter's Toowoomba's branch for collection for 3 months, and the size will be at the promoter's discretion. If the prize is not collected or the eligible entrant's size and delivery address is not provided by the end of the 3 month period, the prize will be forfeited.
- 14. The promoter's decision in respect of all matters to do with the competition will be final and no correspondence will be entered into.
- 15. Any personal data relating to the entrant or any other entrants will be used solely in accordance with current Australian Privacy Laws and will not be disclosed to a third party without the entrant's prior consent.
