FDIC DRONE PROGRAM GIVEAWAY (the "Sweepstakes")  
OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: The Sweepstakes is open to all United States public state and local police and fire departments submitting a valid entry (each an "Agency"), including agreement to all of these Rules during the Sweepstakes Period. Employees of the Sponsors, W.S Darley and Atlanta Drone Group (d/b/a Skyfire Consulting), their affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees or employers thereof are not eligible to participate in the Sweepstakes. For-profit organizations are not eligible to participate in the Sweepstakes. Natural persons are not eligible to participate in the Sweepstakes their personal capacity, must be over the age of 18 at the time of submission of an entry, and must have authority to bind the stated Agency sufficient to enter such Agency in the Sweepstakes. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsors. Each contestant Agency may enter only once. Each contestant Agency's submitting representative must provide the information requested. No Agency may enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. Use of fraudulent methods or attempted to circumvention of the Sweepstakes Rules may result in removal of submission from eligibility at the sole discretion of the Sponsors. Submissions from multiple representatives of the same Agency may be combined into a single entry for such Agency at the sole discretion of the Sponsors.

5. Prizes: The Winner of the Sweepstakes (the "Winner") will receive one (1) DJI Mavic 2 Enterprise unmanned aircraft, a program manual customized to the Winner and its standard operating procedures, a two-day onsite unmanned aerial vehicle training course with admission for up to six (6) operators affiliated with the Winner, and preparation and filing of an application to the Federal Aviation Administration for authorization for Winner to operate a specified unmanned aerial vehicle consistent with a nationwide Certificate of Authorization ("COA"). Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Sponsors. No cash or other prize substitution shall be permitted except at the Sponsors' discretion. The prize and all aspects thereof are nontransferable. Any and all prize-related expenses, including without limitation any and all

federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Sponsors to use Winner's name, logos, personnel likenesses, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

By submission of an entry, each participating Agency and each natural person submitting such an entry on behalf of such agency agree to receive communications from each Sponsor, including solicitations for products and services offered by Sponsors, at the contact information included in the entry submission.

Invalid Entries and Fraud: Sponsors reserve the right, in their sole discretion, to cancel, terminate, modify or suspend the Sweepstakes should virus, bug, non-authorized human intervention, fraud, or other cause beyond Sponsors' control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such case, Sponsors may select the Winner from all eligible entries received prior to and/or after (if appropriate) such action. Sponsors reserve the right, in their sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or website or violates these Rules. Sponsors reserve the right, in their sole discretion, to maintain the integrity of the Sweepstakes, to void entries for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Sweepstakes rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately damage any website or undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Sweepstakes and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.
