PIH Announces Preliminary OpFund Grant Eligibility for CY 2020

Today via the Financial Management Division (FMD) email list, HUD's Office of Public and Indian Housing ([PIH](#)) announced that it has published the preliminary operating fund (OpFund) grant eligibility for CY 2020 for all public housing developments based on HUD-52723 and HUD-52722 submissions. PHAs can review their preliminary OpFund eligibility in the PHA Form 52723/52722 Modules at the [OpFund web portal](#). If you do not have access to the portal, you can follow the directions found [here](#).

PHAs should contact their local field office by email with any questions or comments about their eligibility. Request for corrections must be provided by email to their field office by close of business **April 3, 2020**. Any request made after this time may be subject to a delay in processing.
