PIH Reminds PHAs to Request Revisions to Forms HUD-52723 and HUD-52722

In an [email](#) Friday to the Financial Management Division ([FMD](#)) [mailing list](#), the PIH office announced that, pursuant to Notice [PIH 2020-03](#), it will accept revisions to Forms HUD-52723 and HUD-52722 until **July 15, 2020**. Acceptable reasons for requesting revisions are described in the email.

The email also states that when creating and submitting a revision, PHAs must start with the form which has the current eligibility amount consistent with the 2020 Operating Fund forms HUD-52723 and HUD-52722 in the [OpFund Web Portal](#). PHAs must submit both forms whether a revision is submitted for changes to the HUD-52723 or HUD-52722. Also, the revised forms HUD-52723 and HUD-52722 must have matching UEL Per Unit Month (PUM) and Eligible Unit Months (EUMs) for a project.

All requests for revisions MUST be submitted to the appropriate HUD field office **no later than July 15, 2020** to ensure that HUD processes these revisions and updates the project's funding faster. HUD does NOT accept requests for revisions after July 15, 2020, unless the revision lowers Operating Fund eligibility.
