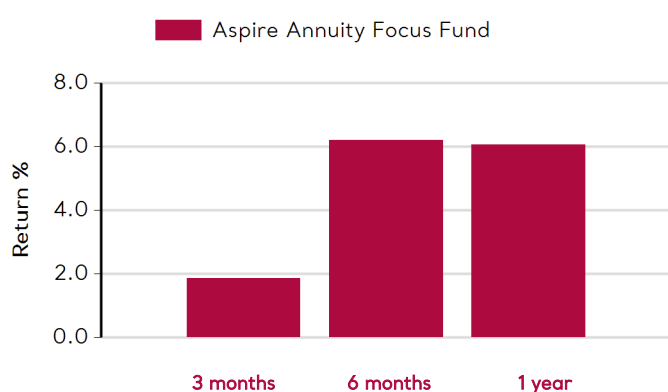

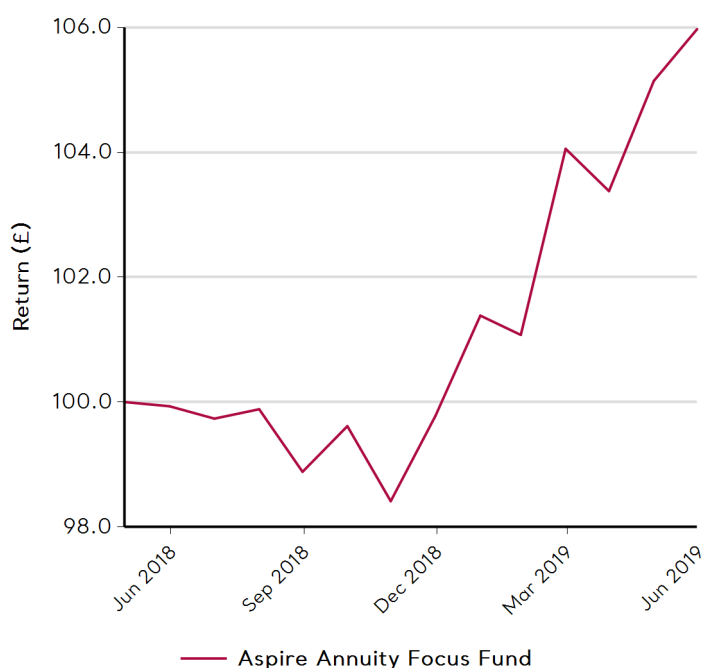

Cumulative Performance since inception

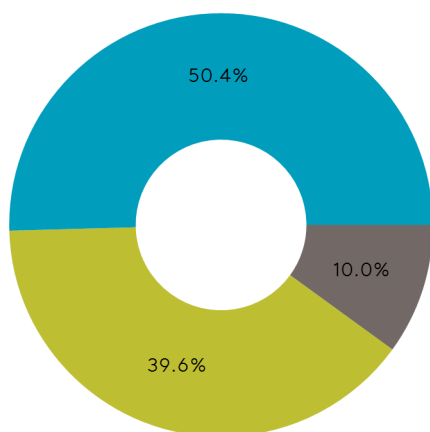
