

Igenomix UK Ltd is an independent private genetics laboratory (Company No.10675550) performing two reproductive genetic services: Preimplantation Genetic Screening (PGS) and testing for Products of Conception (POC). The laboratory also offers other services that are outsourced to the headquarters in Valencia, Spain including Endometrial Receptivity Analysis (ERA), Carrier Genetic Testing (CGT), Sperm Aneuploidy Testing (SAT), Preimplantation Genetic Diagnosis (PGD) and a non-invasive prenatal test (NACE). The laboratory is an affiliate of Igenomix SL where the company holding for Igenomix UK Ltd is located.

In order to ensure that the needs and requirements of users are met, Igenomix UK Ltd undertakes to develop continual quality improvement by:
