2017 REV Official Rules and Regulations 1. REV is sponsored by Treynor State Bank, ("TS Bank") 15 East Main Street, P.O. Box A, Treynor, IA 51575. REV shall be open to the legal residents of the United States, who are at least 18 years of age ("Entrant"). 2. No purchase or donation is necessary in order to enter or win. Participation will be determined solely on the submission of REV applications to TS Bank at the address designated in paragraph #1 or emailed to marketing@tsbank.com. REV applications will be available beginning July 1, 2017 at tsbankrev.com. All applications must be submitted by October 1, 2017, to be eligible. Potential participants may email, hand-deliver or mail applications, but TS Bank is not responsible for the cost of mailing. 3. The first round of REV (Day One) will be held from 1 pm - 4 pm on October 10, 2017 and (Day Two) from 1 pm - 4 pm on October 11, 2017 at TS Bank's downtown location at 43 Scott Street in Council Bluffs, Iowa. Each pitch will last approximately 10 minutes to a panel of four voting panelists. Each participant will have an additional 5 minutes for questions. Participants will be notified if they are moving on to the finale round by October 15, 2017. Once notified they must submit additional documents including: references, finacials including tax returns along with governance documents prior to November 1, 2017. The REV finale will begin at approximately 5 pm on December 1, 2017, at The Venue, inside of Harrah's in Council Bluffs, Iowa. TS Bank will establish the agenda for the finale. The final 5 minute pitches will be given with an additional 10 minutes of questions. 4. A team of four voting panelists, consisting of business owners, business consultants, realtor consultants and bank lenders will determine the finale winners. 5. The maximum number of winners may be up to five individual businesses ranging with a cash prize of \$1-\$25,000 dependent on the judges and investors at the event.
