Pursuant to Rule 704(7)(i) of the Listing Manual of the Singapore Exchange Securities Trading Limited ("SGX-ST"), I confirm that I have prior experience as a director of a listed company in Singapore. Note to item (j) under 'Information required under Rule 704(7)(h)': Mr Benedict Kwek Gim Song was an independent and non-executive director of Auston

International Group Ltd ("Auston"), a SESDAQ listed company. In 2004, Auston reported to the SGX-ST and the Commercial Affairs Department, an alleged malfeasance involving its then chief executive officer for alleged overstatement of revenue and profits as well as alteration and forgery of Auston's contracts with university service providers. The alleged malfeasance is currently still pending investigations by the Commercial Affairs Department. Following the subscription of additional capital by new investors in early 2005, Mr Kwek resigned as a director of the company in August 2005.
