HSBC International Trustee Limited ("HKIT") is the trustee of a trust that owns 100% of Deluxe Assets Holdings Limited (BVI) that has an indirect interest in the shares of the Company. HKIT is thus deemed to have an interest in the shares of the Company.</p> <p>HSBC Bank plc substantially (94.9%) owns HSBC Europe (Netherlands) BV, which wholly owns HSBC Private Banking Holdings (Suisse) SA ("HPBH"). As a result of a transfer by HSBC Bank Bermuda Limited of all its shares in HSBC International Trustee Limited to HPBH, HSBC Bank plc is now deemed to be a substantial shareholder of the Company.</p> <p>HPBH is a wholly-owned subsidiary of HSBC Europe (Netherlands) BV, which is substantially owned (94.9%) by HSBC Bank plc which is a wholly-owned subsidiary of HSBC Holdings plc.</p>
