Disposal by NutriAsia Pacific Limited ("NPL") of 15,000,000 Del Monte Pacific Limited ("DMPL") shares in the open market.

HSBC is deemed to have an interest in the DMPL shares held by NPL via the Twin Palms Pacific Trust and the Star Orchid Trust, of which HSBC is the trustee.

The Twin Palms Pacific Trust is a Campos family trust, the beneficiaries of which are Mr Joselito D. Campos, Jr. and his children. As trustee of the Twin Palms Pacific Trust, HSBC owns 100% of Golden Chamber Investment Limited, which owns 65.4% of NutriAsia Inc., which owns 57.8% of NutriAsia Holdings Limited, which in turn owns 100% of NPL.

The beneficiaries of the Star Orchid Trust are the Campos family members, including Mr Joselito D. Campos, Jr. and his children. As trustee of the Star Orchid Trust, HSBC owns 100% of Star Orchid Limited, which owns 100% of Well Grounded Limited, which owns 42.2% of NutriAsia Holdings Limited, which in turn owns 100% of NPL.
