Description	The Board of Directors of Del Monte Pacific Limited (the "Company" or "DMPL") would like to announce that initiatives carried out by the DMPL Group have resulted in improved terms in its supply agreements with the following key partners: SUPPLY AGREEMENT WITH DEL MONTE ASIA PTE LTD The DMPL Group has entered a new supply agreement ("the Agreement") with Del Monte Asia Pte Ltd ("DMA"), a wholly-owned subsidiary of Kikkoman Corporation ("Kikkoman"). The Agreement, which takes immediate effect, supersedes DMPL Group's long-term supply agreement with Kikkoman, which Kikkoman had served notice to terminate with effect from 30 June 2008. Please refer to SGX Announcement No. 00014 on 30 May 2005 "Kikkoman Issues Notice to End Supply Agreement".
	One of the terms of the agreement allows the DMPL Group to sell directly to private

label and industrial customers in DMA territory, subject to certain conditions. This

The Kikkoman Group owns the Del Monte brand rights for the Asia Pacific excluding the Philippines and the Indian sub-continent. The Agreement with DMA will not include Japan. The territory of Japan will still be covered under the old agreement until its
