LOAN AGREEMENT

Melbourne, Australia; 17 November 2017:

Jayex Healthcare Limited (ASX: JHL) (**JHL** or **Company**) is pleased to announce that, further to the Company's announcement on 11 October 2017, the Company has amended its Loan Agreement (Agreement) with Covenant Holdings (WA) Pty Ltd ('Covenant'), a related entity of the Company's Chairman and major shareholder, Mr Michael Boyd, to secure further funding for the Company. Under the revision to the Agreement, Covenant has increased the Company's loan facility by \$300,000 in order to fund the Company's working capital requirements.

This loan facility provided by Covenant will bear interest of 12% per annum with a repayment date of 1 April 2019 and is an unsecured loan.

The Board is of the view that the terms on which Covenant has agreed to provide the loan facility are better than those available to the Company from commercial lenders and that the Agreement is otherwise on arms' length terms.
