## ***Jayex Healthcare lists on the ASX***

**Melbourne, Australia; 17 December 2015:**

Jayex Healthcare Limited (ASX:JHL) (**Jayex** or **Company**), developer of healthcare service delivery systems, commenced trading today on the Australian Securities Exchange (ASX) following the successful completion of an initial public offering (IPO) which raised \$8 million.

Jayex's Executive Chairman Mr Michael Boyd, previously a founder of Sonic Healthcare, said: *"We are delighted to have listed on the ASX and are pleased with investors' response to our IPO, which closed oversubscribed. We look forward to successfully developing and delivering our suite of integrated healthcare service delivery systems."*

In conjunction with the completion of the IPO and its ASX listing, Jayex has completed the acquisition of its new United Kingdom-based subsidiary Jayex Technologies Limited (Jayex UK), which developed the Enlighten patient workflow platform used by Jayex. Jayex UK's managing director Agam Jain will remain in a senior executive role. Earlier in 2015 Jayex acquired Appointuit Pty Ltd and its online appointment booking system, with Appointuit founders Rosemary and Gordon Cooper remaining in senior management roles. Rob Mantel will continue as Chief Executive Officer of Jayex's other Australian operations.

Jayex is best known in Australia and the UK for its self-service kiosks, part of its Enlighten patient workflow platform that allows patients entering hospital to check in by scanning a barcode. Enlighten is used in 33 hospitals in the UK and at Western Health's Sunshine Hospital and Peninsula Health in Victoria, along with 1,900 UK general practices and 80 in Australia.

Appointuit is integrated with the majority of the practice management software systems on the market and has over 2,000 GP users. It also offers a platform called Engage, which allows patients to order repeat scripts and specialist referrals from their regular GP and includes an SMS/email reminder system for practices.

Jayex plans to increase its market share in GP clinics and hospitals but also to deploy Enlighten to allied health providers, which presents a significant market opportunity for the Enlighten business.

While boosting the Enlighten and Appointuit arms is a priority for Australia, the UK and New Zealand, Jayex plans to target overseas markets in Asia and North America with two of its other technologies which are currently in development.

The first is a proprietary prescription delivery service, Pharmacy Delivery 2 U (p2u<sup>®</sup>), currently in beta testing, which will enable remote processing of prescriptions and the ability for patients to request an express pick-up at a participating pharmacy or for the medications to be delivered to the patient's home, office or other location.

The other is the BluePoint<sup>®</sup> Remote Dispensing Terminal, a technology which facilitates a pharmacist-controlled ATM-style remote dispensing terminal that remotely processes prescriptions

and provides on-the-spot dispensing of standard pharmaceutical products. This product will be aimed at overseas markets.

Mr Boyd said:

*“The main aim of Jayex Healthcare is to develop an integrated suite of best-of-breed technologies that can help primary and acute care providers with increased efficiencies, with Jayex acting as one point of contact for healthcare providers.*

*“We look forward to achieving our objectives and providing valuable and useful services to the health services industry and its clients. I would like to thank our long term and new investors for their support.”*
