"We are a large (13,500 patients) behavioral health practice incorporated with a general medical practice, so we needed an EHR solution that would keep all patient data on one comprehensive record while still meeting specific governmental charting guidelines," said Stacey Lee, Director, Rocking Horse. "All our psychiatrists use the complete EHR instead of paper to chart patients. The medications are entered in the template and are e-prescribed, except for controlled substances." The e-prescribing model makes for effective and efficient prescribing for parents who are concerned they might run out of much-needed medicines.

"If a parent calls in for a refill before sending their child to school, we have all pertinent information at our fingertips, so instead of running around looking for a chart, we can access the patient record and send in a refill electronically," Ms. Lee said. "Having all the information in the EHR makes it quicker to deal with parents and patients and answer their questions or concerns." This ability to reconcile medications is a key factor to the success of the EHR at Rocking Horse.

A comprehensive tool to track medications

"When you start a patient on a new stimulant, we need to make sure they are eating, sleeping, don't have weight loss, or have any adverse reactions. Now we can follow patients closer with specific tasks in the EHR," commented Jodi Fain, IS Support, Rocking Horse. "We run any report needed to effectively follow up with patients concerning medications. Our support staff and nurse care coordinator are responsible for following up with these patients, and we use that data to make sure we are complying with Ohio Board of Health regulations as well as our own internal standards."

At Rocking Horse, the level and intensity of therapy necessitates developing a specific comfort level with patients and more importantly, parents. "We treat a lot of children with ADD/ADHD, as well as lots of school-related issues including depression," Ms. Fain said. "It is crucial that we establish an overall comfort level with parents when they come in and know how their visits went. Previously, when parents brought their children in for a medical or behavioral visit, there was little or no data on the visit. Now our psychiatrists have it at their fingertips."

Deployment of NextGen Ambulatory EHR means Rocking Horse can stratify a patient by diagnosis. "Now we don't have to separate our patients by behavioral health and medical needs," commented Ms. Fain. "We can have patient registries pulled and run reports to make sure each patient is followed and any needed medicines prescribed. We can get info on medications and figure out if the patient is due for a refill. But we are not just a behavioral health clinic; we believe in treating everyone as a whole."
