#### **Client Background**

Australian cricket is administered by one national body (Cricket Australia or CA), six state and two territory associations.

As national governing body for the game in Australia today, CA connects to cricket's local and state levels through its members, the six state cricket associations. The two territory associations are associate members.

At an international level, CA was a foundation member of cricket's world governing body, the International Cricket Council (ICC) and is one of 10 ICC full members.

CA is headquartered in Jolimont in inner Melbourne, with its high performance facility, the BUPA National Cricket Centre, located in Albion in inner Brisbane.

#### **Business Challenge**

The challenge for CA was one familiar to many businesses – that of visibility and accountability for risks and their associated treatments, and the maintenance, management and treatment of a growing body of risk-related information and data, on excel spreadsheets.

CA introduced a risk management framework in 2011 and its risk team had worked hard to develop the requisite risk registers, risk appetite statements, risk rating matrices and the like while also promoting the concepts and benefits of enterprise risk management across the organisation.

This framework was effective in helping CA to identify and analyse risks, and record them along with their existing controls and required further treatments.

However the spreadsheet-based system of risk registers was less effective at assigning ownership and accountability for individual treatments for risks, and in giving the risk team, senior management and board the visibility needed to fully understand the level of risk accepted by CA in a given area of operations. Further, risk reporting to the senior management group and board was made difficult through the use of manually-updated spreadsheets

#### **Solution**

The CA risk team developed a business case for the implementation of an online risk management software system, and after a rigorous tender the contract was awarded to PAN Software. During the tender evaluation and subsequently with a wide range of users the feedback has been that the system is user-friendly, and contains good functionality, and is effective at addressing the two key concerns of treatment accountability and improved reporting.

An added bonus has been the ability to include state cricket associations as system users, through a combination of flexible pricing structure and technical authentication protocols allowing them simple, single sign-on access.

#### **Results**

RiskWare's ERM module has been rolled out to CA and the various state cricket associations with rapid improvements in risk awareness, accountability and ownership. Reporting to CA's board and senior management group has improved in content and style, and CA now has a more consistent and holistic understanding of the risks it faces and of those faced by the state cricket associations.
