






5. Duration of Processing

We store your personal data for as long as you continue to give us your consent, or for as long as Fisher has a legitimate interest in storing the data. Any possible legal obligations may affect the duration of processing (i.e. we store your data for as long as we are legally required to).



6. Your Rights

As a person whose data we are storing you have the following rights, and requests to exercise them can be submitted by sending an email to: Suz-Anne Kinney, suz-anne.kinney@forest2market.com.

Right of access

You have the right to access personal data that we have saved concerning you. We will provide it to you for free. If you notice any errors or deficiencies in your data, you may ask us to rectify or correct the data.

Right to object

You have the right to object at any time to the processing of your personal data, if you feel that we have processed your personal data in violation of the law or that we do not have a right to process some of your personal data.

Right to erasure

If you feel that the processing of some of the data concerning you is not necessary for our tasks, you have the right to request us to erase the data in question. We will process your request, after which we will either erase the data or provide you with a justified reason as to why the data cannot be erased. If you disagree with our decision, you have the right to submit an appeal to your local Data Protection Ombudsman. You also have a right to demand that we limit the processing of the disputed data until the case has been resolved.

Right of appeal

You have the right to submit an appeal to your local Data Protection Ombudsman if you feel that our processing of your personal data is in violation of the current data protection legislation. Please be in contact to us first to see if the matter can be resolved by us.



7. Regular Sources of Data

We obtain all the data that we process from your employer, publicly available records or directly from you.



8. Other Processors

We process personal data in the secure servers of personal data *processors* or in our own facilities. This processing is done on our behalf and we have ensured that all the parties processing your personal data comply with the data protection legislation.

We classify these processors according to whether the regular duties of the processor's personnel include the inspection and processing of your personal data. If yes, the party in question is a *subcontractor*. If the scope of the service is mainly related to the technical processing and saving of data, the party in question is a *service provider*.

10. Transfer of Data in and out of the EU

While we collect information from industry insiders who work all across the world, we store the data in the United States. We have selected industry leading data centres located in the United States as storage places for your data.

If we are obligated to disclose personal data under applicable compelling legislation, personal data may be transferred outside the United States.

Privacy Shield

It is possible that some of the above-mentioned service providers duplicate some data outside the United States to the EU/EEA. Data is duplicated to make sure that your data will also be safe in a situation where the primary servers malfunction.

We have ensured that all of the service providers that we use have joined the EU-US Privacy Shield program (<https://www.privacyshield.gov/list>), aiming to guarantee the data security of European data in the United States. The European Commission has stated that service providers certified with the program in question observe a level of data security and data protection which complies with high European standards.



11. Principles of Data File Protection

The secure processing of your personal data is important to us. Our CRM service is provided by Constant Contact

1. Access to the system requires a username and password. The system is also protected with firewalls and other technical methods.
2. Dedicated Security and Compliance team.
3. Use of the data file is protected with user-specific usernames, passwords and access rights.
