Reviewing the potential for greenhouse gas mitigation in transport

Australian Low Carbon Transport Forum 2011

A new Australian Low Carbon Transport Forum (ALCTF) will get underway in July 2011.

Led by a project secretariat comprising CSIRO, BITRE and ARRB Group, the ALCTF will seek to synthesise views and knowledge on carbon challenges in transport via workshops, networking and information exchanges over a 6 month period.

The aim of the ALCTF is to assess the cost, potential size and limiting factors of the full range of greenhouse gas (GHG) abatement options and strategies in the transport sector by inviting transport stakeholders to share their high level knowledge and discuss information presented by their peers and the project secretariat.

The impetus for the study is to bring together transport sector stakeholders, experts and other knowledge holders who do not normally have the opportunity to exchange information outside of their usual domain, mode or industry grouping. It is also contended that abatement options in the transport sector remain limited and poorly defined due to the diversity of the sector and limited exploration of the barriers to be overcome.

Together this forum will develop a set of realistic GHG reduction and carbon abatement options, define their potential by applying a common and transparent methodology using non-confidential contributed data and advice from participants. The project secretariat will commence the discussion with a position paper that takes a first cut at defining the knowledge base from existing publications and research.





The information developed by the forum will be collected in a report at the end of the process to guide transport stakeholders in their strategic investment and policy development.

Why participate in the ALCTF?

- Help to establish an influential perspective on the directions for the transport industry on emerging carbon and GHG challenges, and to present a stimulus to governments to formulate complementary and/or enabling policy and regulatory initiatives
- Be part of a robust, wide-ranging and incisive dialogue about the 'Low Carbon Transport' (LCT) outlook among stakeholders from all modes and fields of transport
- Help to foster improved collaboration and outcomes in existing strategies and initiatives between industry, research and government, as well as more effective networking and collaboration in future for new endeavours among key stakeholders and researchers on GHG and carbon reduction challenges.

Who should participate?

The primary membership of the ALCTF will be the project secretariat, comprising representatives of CSIRO, BITRE and ARRB Group and invited participants from the transport sector. Invited participants will include a wide range of industry, government and community groups. The aim is to represent the diversity of the sector and its interested stakeholders. The participants will come together in at least three workshops to be convened in separate locations. This will allow people with a wide range of relevant interests, perspectives and experience to take part.

What is the planned ALCTF program?

Starting in July 2011, the ALCTF will proceed with three workshops in various locations:

- Workshop 1 Project overview, sharing our collective knowledge base and identifying initial knowledge gaps and options for addressing them
- Workshop 2 –Reviewing project secretariat analysis of input from the previous workshop, sharing additional information, defining the remaining knowledge gaps and the challenges they represent
- Workshop 3 Reviewing the draft written report of workshop analysis, outcomes and lessons.

What results can you expect from the ALCTF?

The main ALCTF output will be a final report from the project secretariat entailing:

- An assessment of the financial cost, potential environmental contribution and limiting factors for a broad range of available options and strategies for GHG emission reduction in the transport sector (from different technological interventions to various types of demand reduction strategies)
- A summary of the knowledge gaps, uncertainties and additional insights and understandings developed through workshop discussions
- Recommendations in regard to knowledge gaps to be addressed and the most promising directions for carbon abatement in the sector.

The second key outcome of the project is to develop a network of multi-mode, discipline and industry knowledge holders who can



continue their conversation in and out of workshop sessions and ultimately beyond this project.

Workshop 1 on 28 July 2011, Melbourne Workshop 2 on 15 September 2011, Sydney Workshop 3 on 3 November 2011, Brisbane
