CITREP+ is a programme under the TechSkills Accelerator (TeSA) – an initiative of SkillsFuture, driven by Infocomm Media Development Authority (IMDA) and in partnership with strategic partners; Workforce Singapore (WSG) and SkillsFuture Singapore (SSG) as well as collaboration with industry partners and hiring employers. TeSA offers various programmes to support professionals to upgrade and acquire new infocomm technology (ICT) skills and domain knowledge that are in demand, and to stay competitive and meet the challenges of a fast-moving digital landscape.

Through continuous upskilling, fresh professionals and mid-career professionals can acquire or enhance technical skills sets which will enable them to remain relevant and productive in their careers.

To build a strong core of specialised local ICT professionals with digital capabilities, CITREP+ is now expanded to support entry-level professionals since 2010 to build specialised ICT skills through broad-based training courses and certifications.

IMDA will work with training providers to curate and offer quality infocomm professional development technology courses and professional certifications that impart knowledge and skills in relevant areas, to develop a skilled pool of ICT professionals for a digital economy.



# CITREP+ FUNDING - Quantum

## How much funding can I get?

- Up to 90% funding of nett payable course fees (excl.GST) for **eligible** professionals (capped at \$3,000 per course application)

# CITREP+ FUNDING – Eligibility

## **Non-SME Organisation Sponsored professionals (Up to 70% funding):**

- Singapore Citizen or Permanent Resident
- Meets course admission criteria
- Sponsoring Organisation must be registered or incorporated in Singapore



# CITREP+ FUNDING – Eligibility

## **SME Organisation Sponsored professionals or Professionals aged 40 & above (Up to 90% funding):**

- Meets all the terms stated in previous slide
- Is an SME as defined by Spring Singapore

OR

- Meets all the terms stated in previous slide
- Applicant is Singapore Citizen
- Age 40 & above as of 1 Jan of the current year



# CITREP+ FUNDING – Eligibility

Companies which meet all of the following criteria can qualify for the Enhanced Training Support under the SME scheme:

- i. Company must be registered or incorporated in Singapore;
- ii. Employment size<sup>2</sup> (at group<sup>3</sup> level) of not more than 200; OR Annual sales turnover<sup>4</sup> (at group level) of not more than S\$100 million; and
- iii. At least 30% local shareholding being held by Singapore Citizens or Singapore Permanent Residents.



# CITREP+ FUNDING - Eligibility

- You must attain at least 75% attendance
- Complete and pass all assessment/project etc





# CITREP+ FUNDING – Eligibility

- Please note that local government agencies and Institutes of Higher Learning are not eligible for CITREP+.
- Employees of these organisations can qualify under Self Sponsored CITREP+ funding

# CITREP+ FUNDING – Claim Process

1. Ensure you have a valid [CorpPass](#) or Sign up for a CorpPass account
2. Ensure you have a valid Organisation Account [Infocomm Competency Management System \(ICMS\)](#) / Register for an Organisation Account on ICMS



# CITREP+ FUNDING – Claim Documents

\*\*If you are a SME applying for 90% funding, you are required to submit an e-copy of the [Company's Declaration of SME Status for Funding Support](#) to [learning@sginnovate.com](mailto:learning@sginnovate.com) preferably at least 1 week before the course starts.

# CITREP+ FUNDING – Claim Process

1. Course & all assessment(s)/project(s) ends
2. Prep all required submission documents and save electronic copies of it



# CITREP+ FUNDING – Claim Process

3. Within **3 months**, relevant personnel log onto [ICMS](#) with CorpPass and submit your application with **all required submission documents (e-copy)**

# CITREP+ FUNDING – Claim Process

4. Within 6 weeks, IMDA will email you and inform you if the application was approved or rejected.
5. For approved applications, payment will be made via GIRO within 3 weeks from time of notification.





# CITREP+ FUNDING – Claim Documents

## Documents for Submission (e-copy)

1. Original or copies of invoice
2. Original or copies of receipt
3. Daily attendance sheet
4. Assessment result slip/certificate
5. [Direct Credit Authorisation Form](#)
