Building and Managing a Comprehensive Fall Protection Program

Managing a fall protection program in the workplace can be a fairly complicated and time consuming endeavor. ORCIG is in the process of developing a multi-module program that will assist our insureds in the development and implementation of a comprehensive fall protection program. This program will address many of the key elements that need to be evaluated such as task specific fall identification, fall equipment considerations & limitations, fall clearance evaluation, adequate rescue plans, companywide training and finally, compliance monitoring.

Additionally, many contractors are now adopting six foot fall protection policies; however, these policies are frequently not managed effectively. Consequently, the equipment utilized, coupled with the available fall clearance, do not arrest an employee's fall prior to contact with lower landing levels. As a result, many workers are at risk for serious injuries or worse. This training will instruct our insureds on the fundamentals that must be evaluated when contractors are working within six foot fall requirements. The program will also educate contractors on the repercussions of having a blanket six foot fall protection rule, but not enforcing or adhering to it properly.
