## LCS Statement of Faith

1. We believe in one Holy and true God who works all things according to the counsel of His own will. In the unity of the Godhead there are three persons: God the Father, God the Son, and God the Holy Spirit. They are all of one substance, equal in power, glory and honor. (1 Cor. 8:6, Matt 28:19)
2. We believe the Bible to be the inspired Word of God, inerrantly given as the rule of faith and life. (2 Tim 3:16)
3. We believe that God created the world from nothing and is sovereign in its governing. God's intention is for man to subdue this creation and to live for the glory of God. (Gen. 1)
4. We believe that all men are sinners and deserving of eternal punishment. (Rom 3:23, Rom 6:23)
5. We believe that God appointed His Son to suffer and die for sinful men, thereby earning their punishment that His elect might believe through His grace, be saved from eternal death, and be made a new creature in Christ. (John 3:16, 2 Cor 5:17)
6. We believe in the present ministry of the Holy Spirit who indwells all Christians, instructing and reminding them of Jesus' teachings. (1 Cor 6:19, John 14:26)
7. The basic system of doctrine is that presented in the Westminster Confession of Faith and the larger and shorter catechisms.

## LCS Statement on Marriage, Gender and Sexuality

1. We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Gen 1:26-27.) Rejection of one's biological gender at birth is a rejection of the image of God within that person.
2. We believe that the term "marriage" has only one meaning: the uniting of one man and one woman in a single, exclusive union, as delineated in Scripture. (Gen 2:18-25.) We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other. (1 Cor 6:18; 7:2-5; Heb 13:4.) We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.
3. We believe that any form of sexual immorality (including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography) is sinful and offensive to God. (Matt 15:18-20; 1 Cor 6:9-10.)
4. We believe that in order to preserve the function and integrity of Liberty Christian School as the local Body of Christ, and to provide a biblical role model to the Liberty Christian School community, it is imperative that all persons employed by Liberty Christian School in any capacity, or who serve as volunteers, agree to and abide by this Statement on Marriage, Gender, and Sexuality. (Matt 5:16; Phil 2:14-16; 1 Thess 5:22.)
5. We believe that God offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ. (Acts 3:19-21; Rom 10:9-10; 1 Cor 6:9-11.)
6. We believe that every person must be afforded compassion, love, kindness, respect, and dignity. (Mark 12:28-31; Luke 6:31.) Hateful and harassing behavior or attitudes directed toward an individual are to be repudiated and are not in accord with Scripture nor the doctrines of Liberty Christian School.
