




- 1. ALL CONSTRUCTION TO BE DONE IN ACCORDANCE WITH STATE
- AND LOCAL ORDINANCES.
- 2. FIELD VERIFY ALL MEASUREMENTS.
- 3. ALL CONCRETE TO BE 3000 PSI 28 DAY STRENGTH.
- 4. 1/2" PLYWOOD OR OSB WALL SHEATHING TO BE NAILED IN ACCORDANCE WITH ICC 600 -2008 (8d COMMON NAILS, 3" OC
- AT EDGES, AND 6" OC AT INTERMEDIATE STUDS.)
- 5. 5/8" PLYWOOD OR OSB ROOF SHEATHING TO BE NAILED IN ACCORDANCE WITH ICC 600 - 2008 (8d COMMON @ 4" OC MIN. AT GABLE ENDS;
- 6" OC MIN. AT EDGES; AND 12" OC MIN. AT INTERMEDIATE FRAMING.
- 6. THIS STRUCTURE IS DESIGNED TO BE IN COMPLIANCE WITH IRC 2015, ASCE 7, AND ICC 600 - 2008 REQUIREMENTS FOR 140 MPH WINDS - WIND EXPOSURE B AND SEISMIC DESIGN CATEGORY D2. WIND AND SEISMIC
- BRACING ACHIEVED THROUGH MOMENT CONNECTIONS AT SIMPSON FASTENERS, WALL SHEATHING, SHEAR PANELS, ROOF SHEATHING, ETC.. 7. CONTRACTOR TO PROVIDE  $\frac{1}{2}$ " PLYWOOD OR OSB PANELS CUT TO FIT, PRE-DRILLED
- AND LABELED FOR WINDOWS/DOORS. HURRICANE PROTECTION SYSTEM BY PLYFASTNER; ICC 600 CORROSION RESISTANT FASTENERS. CONTRACTOR TO PREPARE EACH WINDOW/DOOR FOR PANEL INSTALLATION PER MANUFACTURER'S SPECIFICATIONS. PREPPED HOLES WITH PERMANENT HARDWARE AND PLUG TO REMAIN IN PLACE. PANELS AND FASTENERS TO BE STORED ON SITE.
- 8. INSTALL SHEAR PANELS INTO WALL CAVITIES AT ALL EXTERIOR CORNERS WITH WINDOW OR DOOR OPENINGS 4' OR LESS FROM CORNER.
- 9. ALL TRUSSES, ENGINEERED LUMBER, AND METAL CONNECTORS TO BE INSTALLED
- PER MANUFACTURER'S SPECIFICATIONS.
- 10. ALL STEEL FABRICATIONS AND INSTALLATION PER AISC STANDARDS.
