Filing Memorandum

Enclosed is a revision to the Government Employees Insurance Company (GEICO) and GEICO General Insurance Company (GG) Private Passenger Auto Rule PPA-P-09, Associate Discount.

This revision removes eligibility for the Associate Discount for all non-insurance affiliates of Berkshire Hathaway. We are removing this discount for non-insurance affiliates because we recently became aware of IRS rules that make discounts to employees of affiliates in different industries taxable income to those employees. This added complexity makes it impractical to continue offering those discounts. Additionally, the revision includes Berkshire Hathaway Shareholders as eligible to receive the Associate Discount.
