Getting to Know the Securities Industry Essentials (SIE) Exam and What it Means for You

Your Guide to Understanding and Preparing for the Upcoming Changes

An Overview of the Securities Industry Essentials Exam

The Securities Industry Essentials (SIE) exam is the biggest opportunity in over 25 years for new professionals in the securities industry. It will significantly modify the licensing process to qualify for future employment.

The SIE will be an entry level exam comprised of common core content across several current representative licensing exams. Numerous candidates will now have the opportunity to qualify for positions in the industry. The content for the SIE exam will be comprised of information that does not frequently change, requiring less maintenance compared to current exams.

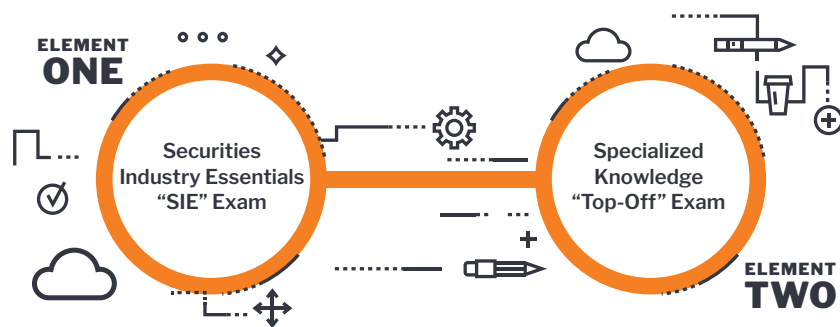

New FINRA Exam Structure

What is it?

On October 1, 2018, the current representative-level qualification exam program will be amended to consist of two test elements:



The goal of this new format is to eliminate duplicative testing of general securities knowledge on exams.

What does it mean for you?

All potential representative-level registrants will take a general knowledge exam (the SIE) and an appropriate specialized knowledge, or "Top-Off" exam to reflect their particular registered role. The SIE exam

will consist of 75 questions (+ 10 pretest/uncscored questions) covering knowledge fundamental to working in the securities industry, such as basic product knowledge, structure and functioning of the securities industry markets, regulatory agencies and their functions, and regulated and prohibited practices. A passing result on the SIE exam would be valid for 4 years.

The SIE exam will be a requirement for anyone wanting to become registered with a FINRA member firm. Other key distinctions include:

- ✓ **Sponsorship by a member firm will not be required**
- ✓ **Enables prospects to demonstrate basic knowledge**
- ✓ **Provides more flexibility and career mobility in the industry**

Each Top-Off exam will correlate to a current representative exam and registration position (e.g., Series 7 and General Securities Representative) and will test content specific to that registration category or job function.

Current vs. New Exam Structures

A candidate for registration with FINRA will be required to pass the SIE exam and Top-Off exam(s) pertaining to their job function to become eligible for registration with a broker/dealer. The Top-Off exams will include the Series 6, 7, 22, 57, 79, 82, 86, 87 and 99 as outlined below.

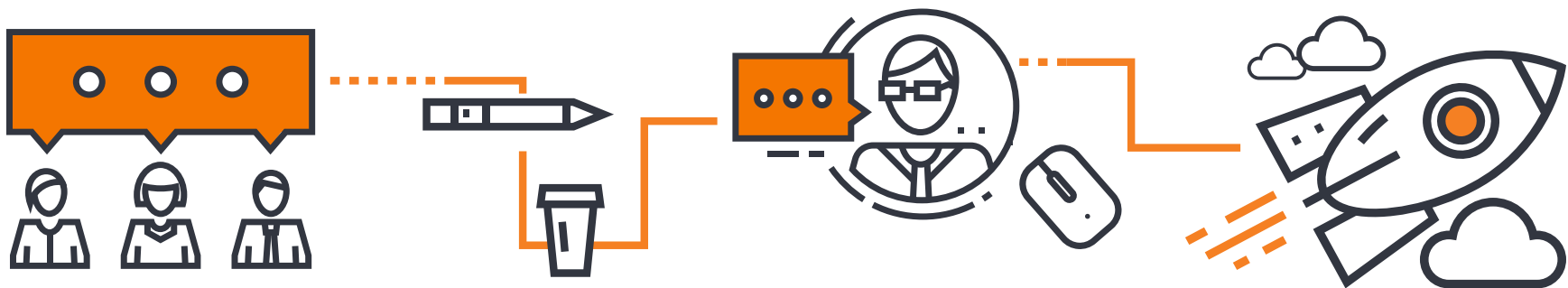

New FINRA Exam Structure Continued

Each Top-Off exam will be shorter than the current qualification exam it is replacing. However, the total number of questions on the SIE exam plus the applicable Top-Off exam could be greater or less than the current exams.

Those who are currently registered as Series 6 or 7 individuals will be granted credit for the SIE exam on their CRD record on October 1, 2018. Current registrants will be considered to have passed the essentials exam, and will only be required to take a rep-level Top-Off exam for the registration position.

As part of the restructuring, FINRA is retiring the current registration categories of Options Representative, Corporate Securities Representative and Government Securities Representative as well as the associated exams, the Series 42, Series 62 and Series 72, respectively. FINRA is also retiring the Order Processing Assistant Representative registration category and associated Series 11 exam. However, an individual registered in any of these categories at the time of the exam change will be able to maintain their registration, but if the individual then terminates that registration and the registration remains terminated for more than two years, they will not be able to reregister in that category.
