## IMPORTANT INFORMATION (Full Terms and Conditions are available in your group leader's group master contract.)

**DEPOSIT:** \$250 per person is required to confirm travel arrangements. Payment is to be made to Keytours directly or the Travel Agent/Group Leader who is responsible for remittance to Keytours. Additional deposit of \$250 is required 120 days prior to departure.

**NOT INCLUDED IN TOUR PRICE:** International or domestic air, unless stated otherwise, passport and or visa fees, any expenses on the U.S. Mainland, camera fees, excess baggage fees, baggage and souvenir forwarding costs; telephone calls; meals not specifically included in the itinerary; after dinner tea or coffee, any beverages such as mineral water or soft drinks, and optional excursions. Also, customary tips to drivers, porters, tour escorts, hotels, and guides are made at the traveler's discretion and are not included in the tour price.

**CANCELLATIONS:** Notice of cancellation must be made in writing directly to Keytours. Penalty for cancellation 120 days or more prior to departure is a minimum of \$250 per person. Cancellation 119 to 60 days prior to departure: forfeiture of all deposits. The following scale of charges will apply when cancellation notice occurs within 60 days of tour departure:

Cancellation days prior:	59-40	25% + air and insurance, if purchased from Keytours
	39-22	50% + air and insurance, if purchased from Keytours
	21-8	70% + air and insurance, if purchased from Keytours
	7-3	85% + air and insurance, if purchased from Keytours
Later, no shows or unused services	100% + air and insurance, if purchased from Keytours	

**REFUNDS:** No refunds will be made for unused portions of any travel service

**RESPONSIBILITY:** Keytours Vacations of Fairfax, VA, USA is responsible for making all arrangements for the travel/tour services offered in the contracted programs to include transportation, sightseeing, and hotel accommodations and related services. The carriers, hotels, and other suppliers providing travel/tour services are independent contractors and are not agents, employees, servants of, or joint ventures with Keytours or its affiliates. All certificates and other travel documents for travel services issued by Keytours are subject to the terms and conditions specified by the supplier and to the laws of the countries in which services are supplied. If the services included in the tour cannot be supplied or if there are changes in the itinerary for reasons beyond the control of Keytours Vacations, the company will arrange for provision of comparable services. Any resulting savings will be refunded by Keytours to the Travel Agent/Group Leader. Keytours reserves the right to accept or reject any person as a tour (group) participant from the tour, to make any changes in the itinerary or services whenever the company deems it necessary to the comfort, convenience, or safety of the tour participants, and to cancel a tour at any time. If Keytours cancels a tour, the company has no responsibility beyond the refund of all monies paid to Keytours by the Travel Agent/Group Leader.

**PRICING:** Keytours Vacations reserves the right to make price adjustments in case of group size reducing more than 10% or destination currency changes greater than 2% or more against USD\$.

**LEGAL ACTION:** Any legal proceedings both on behalf of or against Keytours Vacations must be instituted only in a federal or state court located in Virginia, USA and such claim will be decided using the laws of the state of Virginia. Any legal proceeding against the company must commence no later than one year after the travel services have been completed.
