The Semester Experience Program

The winter Semester Experience begins January 19, 2021, and concludes April 30, 2021. Tuition is \$7,995 which includes access to the Year On virtual platform, all instruction, all coaching, a virtual volunteer project placement, and a virtual externship placement.

A deposit of \$1,000 is due upon registration in order to confirm your participation. The deposit is refundable for 48 hours from the time of submission, after which it is non-refundable. The remaining balance is due in full by January 15, 2020. A tuition payment plan is available which extends the total of monthly tuition payments, concluding in April; contact us to inquire about it.

The Flexible Experience Programs

The tuition for Flexible Experience programs is \$1,995 which includes access to the Year On virtual platform, all instruction, and all coaching.

A tuition deposit of \$495 is due upon registration in order to confirm your participation. The deposit is refundable for 48 hours from the time of submission, after which it is non-refundable. The remaining balance is due in full the day before the start of the program.

The Virtual Experience Program

The 2020 Virtual Experience begins September 8, 2020, and concludes December 18, 2020. Tuition is \$7,995 which includes access to the Year On virtual platform, all instruction, all coaching, a virtual volunteer project placement, and a virtual externship placement.

A deposit of \$1,000 is due upon registration in order to confirm your participation. The deposit is refundable until July 15. The remaining balance will be paid in two equal installments due on August 15 and September 15. A tuition payment plan is available which extends the total of monthly tuition payments, concluding in December.

If you are adding on housing for 15 weeks, the full cost of the housing add-on (\$6,000) is due by August 31.

Flexible Payment Plan Option

We offer a flexible payment plan for families who wish to extend their payments over time. The cost to use this option is normally \$500 but has been waived for fall 2020 and winter 2021. Late Payment Fee

If payment of the program balance is not received by the date noted on your account statement, a late payment penalty of \$25 per day will apply.

Cancellation Policy

All cancellation requests must be emailed to admissions@yearon.com.

After the program begins, no refund will be made to a fellow who voluntarily withdraws from the program unless it is due to an unforeseeable event, including but not limited to significant injury, physical illness, or psychological illness documented by a physician, which precludes the fellow from continuing in the program. Any event which is deemed foreseeable due to a pre-existing physical condition, such as failure to take medically necessary prescription medication, that results in a request for refund will be reviewed by Year On staff and approved or denied at our sole discretion. In the event that a fellow should wish to withdraw or cancel after the program begins, we will work closely with you to determine the best route forward.

No refunds will be provided to fellows whose behavior during the program results in expulsion. Refer to the program handbook for details.

Other Conditions

Following submission of the tuition deposit, fellows in our in-person programs must complete the necessary paperwork, including the Program Contract, Waiver & Release of Liability, Medical History Form, and a background check.

Year On reserves the right to disqualify any fellow prior to joining any program on the basis of medical conditions or other circumstances that could cause them to be unfit for the program. Should this occur, we will work closely with you throughout this decision-making process. Our primary concern is for the safety of each fellow throughout the duration of the program.
