

Aires COVID-19 Business Continuity Communication

Aires is closely monitoring the developments regarding coronavirus (COVID-19). In accordance with our Business Continuity Plan, Aires is taking steps to mitigate service disruptions while ensuring the health and safety of our most valued assets, our Aires employees. We continue to stay apprised and compliant with pertinent governmental and health regulations in the locations in which we operate and serve. In response to the threat of a global pandemic, we established a COVID-19 task force within our organization that is dedicated to proactively managing company risk and communicating appropriately to our employees and customers. Our task force is comprised of stakeholders from throughout the organization and is committed to acting in the best interest of our employees and customers. Summarized below are critical actions and plans implemented by the organization to-date:

REMOTE WORK

Aires' non-US locations implemented remote work and social distancing arrangements. In addition, any employees who have recently travelled internationally for business or personal reasons are asked to work remotely for a quarantine period of fourteen days. Employees concerned about coming to the office due to existing medical risk factors are encouraged to talk with their direct manager regarding how to best work from home. Aires continues to monitor and communicate to employees regarding broader implementation of remote work and social distancing.

CONNECTIVITY

In preparation for a potential transition to full remote work status, we conducted extensive infrastructure and load testing to ensure our employees' ability to securely connect to our Aires systems remotely. Aires staff are equipped with the necessary equipment to work remotely, including laptops and monitors. The nature of over 95% of Aires job functions are well-suited for remote work and can be fully executed successfully outside of Aires' offices. As such, Aires anticipates minimal disruption to service, connectivity and customer accessibility for our team members when working remotely.

TRAVEL

Travel restrictions were implemented on Monday, March 9, limiting domestic and suspending all air and international travel. Employees were encouraged to refrain from attending conferences/gatherings of more than 100 people. In addition, employees with previously planned international personal travel have been required to share their travel plans with our human resources team and to self-quarantine for a period of fourteen days upon return.

MOBILITY AND SHIPPING IMPACT

Due the nature of Aires' business, we are also subject to work stoppages, travel complications, governmentimposed quarantines and restrictions in the most affected locations. As such, we may experience delays in
