Key Responsibilities:

Sourcing Capability

- Achievement of individual KPIs, agreed with line manager
- Source products ensuring route integrity and chain of custody transparency
- Proactively identify and report "Sourcing Gaps" within the sourcing group
- Provide timely and constructive feedback to line manager in order to contribute to the maintenance of Supplier Assessments as per current agreed format
- Engage in professional and ethical rapport with suppliers and manufacturers
- Collaborate with CTS peers in order to build a regional understanding of supply analysis and actively participate in building a supportive regional CTS team
- Working with project and BD teams to build a strong collaborative partner based relationship

Enquiry / Project support

- Maintain individual project tracker ensuring sourcing, delivery and aftercare responsibilities are kept up to date
- Execute sourcing requirements for clinical trial projects against agreed KPIs & timeframes
- Liaise with Group support functions and suppliers to ensure the delivery against awarded projects
- Provide excellent customer service to all internal and external clients requiring product(s) from exclusive distribution agreements
- Provide relevant feedback to line manager regarding client [internal and external] service feedback and action improvements where opportunity exists
- Work effectively with project management, peers and BD team to identify, understand and help manage client relationships, expectations and service
- Contribute to the comprehensive reporting for both the Customer Relationship Management tool and the Delivery Schedule in a timely manner
- Adhere to compliance and traceability expectations throughout the project supply chain

- Ensuring all license documentation is in place when considering specific distributor/supplier options
- Collaborate with the CTS team to identify opportunities to improve supplier, manufacturer and client experience
