

What is this Privacy Policy for?

This privacy policy is for this website www.truckcartellegalaction.com and served by The Road Haulage Association and governs the privacy of its users who choose to use it.

The policy sets out the different areas where user privacy is concerned and outlines the obligations & requirements of the users, the website and website owners. Furthermore the way this website processes, stores and protects user data and information will also be detailed within this policy.

Storage of your personal data

All information you provide to us is stored on secure servers operated or utilised by HubSpot. Information may be transferred and stored at a destination outside the European Economic Area. Use of Cookies
