IPAM Lisboa has been following, from the beginning, the evolution of the public health crisis associated with COVID-19 pandemic. Thus, our face-to-face activity will start in a progressive and phased manner, according to the guidelines and orientations, as always, of the competent entities, and prioritize the safety and health of our students, teachers and employees. In accordance with these assumptions, we are committed to maintaining the activity trough distance teaching, with high quality standards and in accordance with the best international practices.

We also inform you that this resolution process and IPAM Lisboa Management's decision is based on the consultation of the Pedagogical Council and the Scientific Technical Council, which met on May 13th, 2020.

Through this notice IPAM Lisboa informs you that it shall proceed with the necessary adjustments considering the specificities of the different courses, whether they are of a Degree, master's or Executive Education level, which due to their uniqueness require it.

Please note that in accordance with the previously referred resolution, the main specificities highlighted are:

### 1. Teaching and other learning activities

Until the end of the academic year, in accordance with the calendar, teaching and learning activities shall take place trough distance teaching. In spite of this, the face-to-face activities communicated on the progressive relaxation of containment measures the will gradually start from 18 May.

### 2. Knowledge assessment

Continuous assessment of knowledge shall occur remotely, independently of its nature;

The first exam period (final assessment) shall occur remotely, within the defined calendar, resorting to alternative methodologies than written tests or exams without consulting notes;

The Scientific Technical Council delegated on the Course Directors and Coordinators of the Scientific Technical Area, the competence to analyze the proposals of the Lecturers concerning the most suitable assessment model for each course unit. The methodologies approved at the Pedagogical and Technical-Scientific Councils of IPAM Lisbon, held on May 13th, 2020, are the following:

Until the beginning of the First Exam Period we shall determine whether the second and special exam period will occur F2F or remotely, as per the health status of the country and the Government's guidelines;

If the health status of the country and the Government's guidelines continue during the second and special exam period, the same assessment procedures are henceforth decided, which in this case are similar to those of the First Exam Period;

The First, Second and Special Exam Period will occur as stipulated in the school calendar;

It is proposed the creation of a Special Final Assessment Exam Period in September (from 1st to 11th of September) directed at students, who were unable to complete their assessment beforehand, with justified reasons and those solely connected to the Contingency Plan arising from Covid-19.

### 3. Academic examinations

Until further notice, internship report related public examinations for Degrees and Dissertations/Professional Projects/Professional Internships for master's shall occur remotely.



We thus encourage all the academic community to continue participating in all the programmed classes and activities through our virtual campus. Remember that lecturers, course administration and the management of this institution continue to work in helping you in the whole process and in whatever is necessary to maintain the quality of the programmes in the current distance teaching model.

We thank you, once more, for your invaluable capacity to adapt and resilience to this situation which has ruled our lives in recent months, hoping that we will see you soon.
