## TERMS AND CONDITIONS

- 1. IMR's liability to the customer or any third party is limited at all times to the amount charged for the services provided.
- 5. Any copying or distribution of the Report, or any use of IMR's name or trademarks, is not permitted without the prior written consent of IMR. Customers who anticipate using an IMR Report in any legal or quasi-legal proceeding shall so notify IMR at the time the sample is submitted.
- 6. Return shipping costs are not included. If the Customer desires return shipping of its sample(s), the cost will be billed to the Customer, handling fees may apply. Unless otherwise requested in writing by the Customer, all samples may be discarded at any time after 90 days from the date of IMR's final report.
