

## **Estate Planning in the Digital Age** Constant Change Necessitates New Tools

Estate plans are no longer complete without the inclusion of digital documents and passwords as part of asset protection and transfer strategy. The legal and fiduciary guidelines are becoming more stringent and recognizing control, transfer, and disposition requirements similarly to tangible assets. What is a digital asset? Simply put, a digital asset is any digital file stored on your computer, electronic device, cellular phone or in the "cloud." Less clear than the procedural requirements for digital assets are the process mechanisms for the eventful execution of these intangible elements of an estate's plan. Some examples of digital assets may include: electronic documents (i.e Life Insurance, Long Term Care and Disability Policy, Will, Annuities, Stocks, Bonds and Investments), passwords, family memories & records, e-mail accounts, domain names, digital currencies (i.e. PayPal balances), backup disks and airline miles.

So, how do we manage the estate settlement process of these assets? Good legal and fiduciary counsel will invariably bring these assets to light,

and include them in accounting for an estate's plan especially if they are of significant monetary value. But, what are the mechanisms that will meet the plan's demands and fulfill your ultimate desires and intents?

What is the Answer? Digital Vaults

All documents, passwords, and information are encrypted automatically.

Digital vaults allow the naming of beneficiaries for each document and password it stores. These designations are easily added or adjusted with a few keystrokes or clicks of a mouse. With the presentation of a death certificate, the documents, passwords and other digital assets are distributed electronically and directly to the parties you have designated in the vault - no probate or settlement process is required.

For the requirements of a contemporary estate plan and the disposition of digital assets and passwords, digital vaults are a valuable tool for your family today, and generations to come. Furthermore, digital assets with significant monetary value have the potential to trigger federal estate tax issues, in which case you should speak to your estate planning professionals about a the use of life insurance as a planning technique.
