

INTELLIFLO PENGU THROW CHRISTMAS COMPETITION – TERMS AND CONDITIONS

- 1. The Promoter of this competition is Intelliflo Limited, of Third Floor, Drapers Court, Kingston Hall Road, Kingston upon Thames KT1 2BQ.
- 2. By entering into the competition, you are agreeing to these terms and conditions and are confirming that you are eligible to enter into the competition.
- 3. The competition is open to all UK residents aged 18 years or over who are employees of a financial services organisation, except:
 - a) employees of the Promoter, their families, agents or

b) any third party directly associated with administration of the competition.

- 4. The competition is free to enter and no purchase is necessary. The Promoter will not accept competition entries that:
 - a) are automatically generated by computer;
 - b) are completed by third parties or in bulk;
 - c) have been altered, reconstructed, forged or tampered with; or
 - d) are incomplete.
- 5. The opening date for entries is 09.00 (GMT) on Thursday 7 December 2017. The closing date of the competition is 09.00 (GMT) on Monday 8 January 2018. Entries received after this time will not be considered.
- 6. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
