More classrooms, please!

The congregation of Evangelical Free Church has outgrown its current facilities. With the need for more classroom space, a decision was made to add on to the church, as well as remodel some existing space.

The 29,000-square-foot addition (18,000-square-foot first floor, 11,000-square-foot second floor) is all learning space. The first floor has been designated as elementary classrooms, while the second floor will serve the senior high education needs. An additional 6,000 square feet of existing space is being remodeled to accommodate the adult classrooms.

Construction details of the addition include a pre-engineered metal building with brick exterior, interior block walls and a Flexcore flooring system to support the second floor. Other amenities include an elevator and operable walls for flexible classroom size.

As with any education, it comes with a price. In this case, Evangelical Free Church is investing \$2.2 million to upgrade its campus to facilitate the education of its congregation. The project began March 1st and is on schedule to finish in January, which means you can look forward to completion photos in our next issue of *The Lacy Ledger*.
