Pre-Paid Incoming Freight

We provide prepaid FedEx labels making it easy for you to ship to us.

2

Recording Garment Details

The NFPA tracking process begins in the receiving department. We add the garment by serial number, manufacturing date, garment type, model/make, size, and primary materials (outer shell, thermal liner, moisture barrier, reflective trim) and note the firefighter to whom it is assigned and receive it for service. Tracking for services performed begins here.

Ozone Cleaning

Each garment is separated into liner and shell for proper handling in the laundry and is Advance cleaned per NFPA 1851 standards. Ozone is used to treat EVERY garment for biohazards, an investment not typical to fire department washers and extremely rare among Verified Independent Service Providers.

Controlled Drying

Mechanical drying harms velcro and reflective trim on the garments. At LION Totalcare, each garment is dried in a controlled environment with industrial dehumidifiers to remove moisture. This process takes hours but is the best way to preserve the integrity and safety of the turnout gear.

NFPA Advanced Inspection

LION is a member of the NFPA committees that determine the gear performance and service standards. LION has been inspecting garments returned from field use for over 25 years. An NFPA Advanced Inspection is performed by LION trained, experienced inspectors who thoroughly examine each garment layer. Inspectors note all repairs needed to make the garment fit for duty.

Manufacturer-Trained Repair Processing

Each repair is meticulously performed by expert garment repair technicians using original materials according to NFPA and manufacturer guidelines.

7

Thorough Q.C. & Shipping Preparation

A quality control inspection is performed as the garment is reassembled and packaged for return to the customer. A packing list that details each garment by serial number, the dates each was cleaned/inspected and repaired if needed, is in the order. Outbound freight is covered by StaySafe.

8

Complete Documentation

In addition to the packing list, a detailed list of each repair performed per garment is included. For an additional fee, customers have the option to receive access to a web portal that tracks all data for the fire department's gear – including assignment records, clean/inspect/repair details by date, retirement dates (if shared with LION TotalCare) and more.

The useful life of turnout gear can be as little as three to five years with improper maintenance and/or storage. Safe, useful life can be as long as seven to ten years if turnouts have been consistently maintained in a cleaning, inspection and repair program and stored properly.

LION TotalCare® has demonstrated that regularly maintaining turnouts from the time they are issued reduces the potential

for progressive damage which can make gear unrepairable. This means that gear can be kept in serviceable condition longer.

One example is the City of Chicago Fire Department (CFD) program that started in 2007 when 15,000 new garments were issued and a StaySafe annual maintenance program was implemented. Despite the fact that the CFD handles approximately half a million responses a year, at the end of 2013 less than 1% of the turnouts originally issued in the program have been replaced. - Decontamination of hazardous materials.
- Damage attributable solely from wearing ensembles in situations other than intended use.
- Damage that arises from conditions under which the ensembles are exposed to excessive heat beyond the conditions which ensembles were designed to withstand to meet NFPA 1971.
- Complete destruction caused by an extraordinary event.
- Damage caused by chemical or biological contamination.
- Damage caused by improper storage.
- Damaged gear enrolled in the StaySafe program that has not been TotalCare-inspected for more than eighteen months.
