PRE-OWNED PEACE-OF-MIND PROMISE TERMS AND CONDITIONS

Campers Inn RV provides a Pre-Owned Peace-of-Mind Promise on eligible pre-owned RVs. This promise assures our customers that our specified list of Exterior, Interior and Motorhome items have been thoroughly inspected and tested to ensure they are functional and working on the day of delivery. Items covered by the Peace-of-Mind Promise that were noted before delivery will be repaired free of charge to the customer. If the repair cannot be fixed immediately, then a repair will be scheduled with the service department. The following terms, conditions and limitations of the Pre-Owned Peace-of-Mind Promise apply:

- 1. Care of the RV: Your RV must be properly operated and maintained in accordance with the maintenance schedule in the owner's manual. Proof of maintenance may be required. It is the owner's responsibility to make sure that all scheduled maintenance is performed and that the materials used meet the manufacturer specifications. The owner must ensure that receipts for completed maintenance work are retained with the vehicle and confirmation of maintenance work is always entered in your scheduled maintenance guide. This documentation may be required in the event a question arises as to whether a malfunction occurred before, on or after the day of delivery.
- **2. After delivery:** The Peace-of-Mind Promise does not extend to issues arising after delivery. Any item(s) not working properly on the day of delivery must have been noted by the customer during the walk-through/demonstration prior to delivery.
- **3. What is Not Covered:** Any items and/or RVs specifically not listed as part of the Peace-of-Mind Promise are not qualified for this coverage.
- **4. Tires:** The tires will be replaced when significant dry rot is present or when the tread depth has reached 4/32 or less. Tires will comply with state ordinances and will not be expired.
- **5. Smoke, LP and Carbon Monoxide Detectors:** Detectors that are over 5 years old, based on the manufacturer's date, will be replaced.
- **6. Fire Extinguishers:** Fire extinguishers over 5 years old, based on the manufacturer's date, will be replaced.
- **7. Leaks**: The windows, roof and slide-outs of the pre-owned RV will be inspected and tested for leaks. Any leaks will be repaired.
- **8. Awning & Awning Fabric:** The awning will function properly and the awning fabric will not be torn. Fading or small pin-like holes in the awning fabric are considered normal wear and tear and are not qualified for coverage.
- **9. TVs & DVDs:** TV and/or DVD systems (if equipped) will function properly. Satellite systems are not qualified for coverage.
- **10. Cosmetic Items:** Normal wear and tear to items such as carpet, trim, linoleum and furniture will not be qualified for coverage.
