GENERAL CONDITIONS OF THE REFERRAL PROGRAM VALID UNTIL 31/07/2020

Article 1: Definitions

Referrer: Any person or company client at iBanFirst

Referee: Any person or company who is not a user of the iBanFirst platform and who has never been a user of the iBanFirst platform, whose contact details have been provided to iBanFirst by the Referrer.

Registration for iBanFirst Services: Registration for iBanFirst services refers to access to the financial
