Late Fees

Students who do not pay their bills by the due dates which have been publicized by the University are assessed a \$100.00 Late Payment Fine.

NEUMANN UNIVERSITY REFUND POLICY

When a student drops or withdraws from a course, he or she will be entitled to a refund or a credit according to the scale below. Fees are not refundable except for those courses canceled by the University. If a student feels individual circumstances warrant an exception to the refund policy, a request for consideration must be made in writing to the Business Office, Attention: Assistant Controller/Bursar, Neumann University, One Neumann Drive, Aston, PA 19014-1298.

The date the withdrawal is entered into the Ellucian Administrative Software System will serve as the basis for computing refunds.

The first scheduled meeting of a course constitutes the beginning of the refund period for that course. The refund period may change based on the length or nature of the course.

Federal Refund Policy

Substantial changes in federal regulations have become effective Fall 2000 regarding Financial Aid repayment when a student completely withdraws from Neumann University.

A complete withdrawal occurs when a student withdraws from all classes. In such instances, financial aid adjustments are no longer related to institutional charge adjustments. The charges adjusted by the University, however, have not changed.

IMPORTANT: It is possible for a student to be charged full charges and receive only a portion of their Neumann University scholarship/grants and/or federal and state aid, based upon the percentage of days completed.
