### Where To Submit Apps

- Apps must be submitted directly to the carrier
  - Electronic submission is preferred.
  - Submit one app at a time when faxing to the carrier.
  - IMPORTANT! Keep a copy of your fax confirmation.
    - The carriers sometimes don't receive a copy of the app for one reason or another, but if you have a copy of the fax confirmation you can resubmit the app with the fax confirmation and they will process the app.
- Medicare Supplements that have a check must be mailed to the carrier.
  - NOTE: Medical Mutual will not accept a check with the application

### Common Mistakes

• The following are common mistakes made when submitting an application causing it to pending or be cancelled.

#### Submitting the wrong or an invalid app

- Most apps now are plan specific. Be sure to check that the app matches the plan requested.
  - Aetna apps coded for each plan. You can't take an app out of one kit and use if for another plan. No PDF's are available to print.
  - Humana apps barcoded, but it's one app for all plans. No PDF's are available.
  - Anthem paper apps include both your encrypted TIN and Cornerstone's encrypted TIN CKHJQPKSMY on the applications
  - Wellcare paper apps that are faxed offers a personalized application page that is encouraged to be submitted for tracking purposes. It is barcoded and specific to the agent. Must be submitted as the final page.

#### Invalid Medicare ID number

• It's best to always see a copy of the client's Medicare card to ensure the current number is on the app.



### Common Mistakes Con't

#### Missing signatures or signature dates

- Always make sure you and the applicant sign and date the application. Remember, you should not sign and date the application until it is in your possession
- Double check that all signature fields are completed and the dates are correct (we see a date of birth or effective date listed as a signature date frequently)

#### Missing or Invalid Writing Numbers

• This is very important as this is how you are paid! In cases when the incorrect writing number is listed on the application the carrier will drop the policy as a house account until a correction is processed.

#### Invalid Election Period

- Be sure to check or write in the AEP election on the application that requires the election to be entered. The carrier won't assume the AEP election.
- While most elections will be marked AEP this time of year, it's still important to make sure you are using the correct election period for age-ins or other special circumstances.

#### Missing Effective Date

• Be sure to enter the effective date in regardless if it is AEP. We have seen apps pend for not entering the effective date.



### **Electronic Enrollments**

- Please be aware that some carriers require electronic enrollment.
- Here is a list of carriers that required electronic enrollment.
  - Mutual of Omaha Medicare Advantage only
  - **SilverScript** lets you write a paper app, but in order to receive commission you must still enter everything into the portal, obtain a verification code, enter that code on the app and then email or fax everything over to them.
  - Gateway submission through Cavulus
- While not all carriers require electronic enrollments, many prefer this method.



### Changes to Medicare.gov

- Beginning AEP 2020 CMS will be offering a new Medicare Plan Finder
  - What does this mean for you?
    - Access to the old plan finder ended in September.
    - Agents that stored the beneficiary's medication list on Medicare.gov will no long have access to this data. They also will not be able to store this data going forward.
    - It asks for a log in, but you can sign in as a guest to look up plans however, it won't save any information.
