- 三、 竞赛项目 比赛设5个组别:

A组 (5段以上, 含5段) B组 (1段至4段) C组 (5级至1级) D组 (5级以下) E组 (女子选手)

四、 参赛办法

采用邀请和选拔两种方式推选出世界各地约100位大学生棋手参赛。

- 五、 比赛办法
 - 1、比赛采用应氏计点制围棋竞赛规则。
 - 2、参赛选手必须为在籍大学生业余棋手。
 - 3、组委会将根据报名情况,制定各组别具体竞赛方法。
 - 4、中国大陆男选手只可参加A组和B组的比赛。
- 六、 费用:选手自行负担国际或国内旅费,主办单位将负担报到后住宿、 餐饮、旅游、比赛等大会期间费用。
- 七、录取名次及奖励

各组别前6名均获得优胜证书及精美奖品。 所有参赛选手获得参赛证书及大会礼品一份。

- 八、 仲裁和裁判员由世界大学生围棋联合会统一选派。
- 九、 未尽事宜另订补充细则。
- 十、本规程解释权属世界大学生围棋联合会。

Regulations for The Fifth Annual World Collegiate WEICHI Championship

I. Organizer:

II. Date: July 9- July 15, 2018

Location: Cambridge University Centre CB2 1RU

III. Competition groups:

Group A (5 Dan or above 5 Dan) Group B (1-4 Dan)

Group C (5Kyu-1 Kyu) Group D (Under 5 Kyu)

Group E (Women only)

IV. Qualification:

One hundred WEICHI players from worldwide universities will be invited and selected to participate in the tournament.

V. Competition Methods:

- 1. Ing rules for scoring.
- 2. The players in the Dan and Kyu groups must be amateur go players and students registered at a university.
- 3. The organizing committee will decide the tournament format for all four groups, according to the number of registered players.
- 4. The male Chinese players are only allowed to enter Group A and B.

VI. Cost:

The international or domestic travel cost associated with getting to and from the tournament site is the student's responsibility. The organizing committee will cover the cost of: accommodation, meals and tours for the players, during the course of the tournament.

VII. Ranking and Awards:

The top six ranked players from each group will win medals and a set of WEICHI equipment. All the players will receive a Certificate of Participation and a souvenir.

VIII. Jury of Appeal and Referee:

The International University WEICHI Federation assigns the jury of appeal and referee.
