About the role:

The Information Security Manager plays an integral part in the architecture, development, implementation of IT Cloud Services, Network, Security Infrastructure services and compliance across Protecht. This role is responsible for managing risks related to information security, business continuity/disaster recovery planning, crisis management, privacy, compliance and maintenance of existing security certifications.

In addition, you would also participate with the CTO and Executive Team to establish strategic plans and objectives, making decisions on administrative or operational matters, and ensuring effective achievement of objectives.

This is a highly visible role with direct line of sight and reporting to the CTO and other Executive leadership.

Key accountabilities:

Responsibilities include but are not limited to:

- Expand and maintain existing security certifications. Lead regulatory and corporate compliance with ISO 27001 and IRAP initiatives as they relate to Protecht
- Identifying, evaluating reporting on, and mitigating information security risks in a manner that meets internal, compliance and regulatory requirements
- Responding to incidents that may occur and overseeing the adoption of cloud operations for strategic applications. Investigate and follow up of security breaches and incidents, if they occur.
- Understand and document IT Infrastructure and Security requirements in alignment with current industry best practices
- Develop strategy, budget and roadmap for Information Security to ensure compliance with industry best practices and standards, including ongoing security assessment and response, identity and authentication services, patch management.
- Oversee implementation of periodic risk assessments of assets to identify any potential vulnerabilities and recommend an appropriate methodology to mitigate identified vulnerabilities and follow up to completion.
- Assess criticality of identified vulnerabilities within the Protecht and Protecht.ERM environment and guide the remediation of these vulnerabilities to meet compliance and maintain a secure environment.
- Design or utilise monitoring systems to ensure confidentiality and integrity of Protecht and Client data and availability of all network services
- Facilitate the selection of 3rd party vendors, software, hardware and other technology business applications with regards to security of service and product.
