TERMS OF USE AGREEMENT

Effective Date: April 8, 2016

Before engaging in any transaction with, or using any website or service provided by LoanStreet LLC, please read this Terms of Use Agreement (this "Agreement") carefully and in its entirety.

Throughout this Agreement references to (i) "we", "our" and "us" is to LoanStreet LLC and any of our subsidiaries or affiliates; and (ii) "you" and "your" is to the institution you represent, all accounts and sub-accounts registered by your institution with LoanStreet LLC and you as a natural person, as applicable.

1. Acceptance of this Agreement; Amendment

This Agreement sets forth the terms and conditions that apply to and govern (i) your access and use of the websites, including the websites located at <u>www.loan-street.com</u> and other subdomains like example.loan-street.com (each, a "LoanStreet Site") owned and operated by LoanStreet LLC, a Delaware limited liability company; and (ii) any service provided by LoanStreet LLC or through any LoanStreet Site (each, a "LoanStreet Service").

In addition to your execution and delivery of LoanStreet LLC's registration agreement upon which your access to and use of any LoanStreet Site or LoanStreet Service is conditioned, your use of any LoanStreet Site or LoanStreet Service also constitutes your continuing agreement to be bound by the terms and conditions contained in this Agreement, LoanStreet LLC's Privacy Policy, any fee schedule and any additional terms and conditions to which you have agreed with LoanStreet LLC, including any loan sale agreement, loan assignment agreement or loan participation agreement that may be in effect from time to time.

Your use of any LoanStreet Site or LoanStreet Service is governed by the current version of this Agreement in effect on the date of such use.

LoanStreet LLC may in its sole discretion modify this Agreement at any time and from time to time and LoanStreet LLC will advise of you of such modifications by providing you a notice by electronic means in advance and by posting the revised agreement on a LoanStreet Site. You agree that the posting by us of the revised terms of use agreement on any LoanStreet Site shall constitute actual notice to you of the revised Agreement then in effect. Furthermore, by using and accessing any LoanStreet Site or LoanStreet Service, you acknowledge and agree to review the current version of this Agreement prior to or at the initiation of each such use. Your continued use of and access to any LoanStreet Site or LoanStreet Service constitutes your acknowledgement of, and agreement to, the then current version of this Agreement.

Please also note that the terms and conditions of this Agreement are in addition to any other agreements between you and LoanStreet LLC, including the LoanStreet Registration Agreement, and any

other agreements that govern your use of products, services, content, tools, and information available on LoanStreet Sites or LoanStreet Service.

LoanStreet LLC may, in its sole discretion, discontinue or change any product or service described in or offered on any LoanStreet Sites or LoanStreet Service at any time.

If you do not agree with any of the terms and conditions of this Agreement, do not use or access any LoanStreet Site or LoanStreet Service.

2. U.S. Person; Tax

You represent and warrant to LoanStreet LLC that you are a United States person within the meaning of Section 7701(a)(30) of the U.S. Internal Revenue Code of 1986, as amended, and that prior to your use of any LoanStreet Site or LoanStreet Service you have delivered to LoanStreet LLC a completed Form W-9 certifying that you are exempt from U.S. federal withholding tax.

You further agree that you shall deliver additional W-9 (or successor) forms promptly upon the obsolescence or invalidity of any form previously delivered by you at any other time prescribed by applicable law or as reasonably requested by LoanStreet LLC.

You agree to promptly deliver to other users of LoanStreet Sites or LoanStreet Services copies of your completed W-9 (or successor) forms to the extent necessary for such users to confirm your status as a United States person not requiring U.S. federal withholding tax and you further authorize LoanStreet LLC to deliver such forms on your behalf. To the extent you are a recipient of any other user's W-9 form, you agree that under no circumstance shall LoanStreet LLC have any responsibility or liability for the content, accuracy, sufficiency or completeness of any user's W-9 form and that the delivery of such W-9 form by LoanStreet LLC is as a courtesy only and is solely for your convenience and benefit.

To the extent LoanStreet LLC is obligated to provide information filings to the U.S. Internal Revenue Service, you agree to promptly assist LoanStreet LLC at your own cost in preparing and delivering such filings to the U.S. Internal Revenue Service.

3. LoanStreet LLC Fees

Your use of any LoanStreet Site or LoanStreet Service may be subject to paying certain fees and commissions to LoanStreet LLC. From time to time, LoanStreet LLC may in its sole discretion deliver to you fee schedules setting forth the fees and commissions associated with your use of certain LoanStreet Sites or LoanStreet Services. Your fee schedule is individual to you and does not represent the fees paid by other parties. LoanStreet LLC may set new fees and alter, modify or change existing fees for access to any LoanStreet Site or LoanStreet Service in its sole discretion at any time and from time to time and without advance notice. You further agree and acknowledge that any fees or commissions you pay to LoanStreet LLC to access any LoanStreet Site or use any LoanStreet Service may differ from those paid by other parties. 4. Access & Interference

a. Access & Site Maintenance

LoanStreet LLC reserves the right, in its sole discretion, without any notice requirement, to change, improve or correct the information, materials and descriptions on any LoanStreet Site or LoanStreet Service and to suspend and/or deny access to any LoanStreet Site or LoanStreet Service for scheduled or unscheduled maintenance, upgrades, improvements or corrections.

- b. Registration
 - i. No Universal Access; Authorized Users Only

Certain LoanStreet Services, and certain pages of a LoanStreet Site, are available only to registered users who have been authorized by LoanStreet LLC to access those services and web pages. Such authorization may require the execution of a LoanStreet LLC registration agreement and satisfactory background information screening. Only registered users of any LoanStreet Site with valid user identification and password are authorized to access such services and web pages. LoanStreet LLC reserves the right to change the requirements to access any portion of any LoanStreet Site or to use any LoanStreet Service in its sole discretion, including changes that may result in you no longer having access to certain portions of a LoanStreet Site or the use of certain LoanStreet Services.

c. Right to Terminate Access

LoanStreet LLC reserves the right, in its sole discretion, to block or otherwise discontinue your access and use of any LoanStreet Sites or LoanStreet Service at any time and for any reason. You agree that LoanStreet LLC shall not be liable to you or to any third party for any such modification, suspension or discontinuance.

We reserve the right to suspend or cancel your registered username and/or password, even without receiving notice from you, if we suspect, in our sole discretion, that it is being used (i) in an unauthorized or fraudulent manner or (ii) by an unauthorized person.

d. No Transferability of Access

Your right to access and use any LoanStreet Site or LoanStreet Service, including your user identification and password, is personal to you and is not transferable by you to any other person. Notwithstanding

anything herein to the contrary, you may, with LoanStreet LLC's permission, transfer the primary account holder to a different person within your institution.

e. User Identification & Password Maintenance

You agree and understand that you are responsible for maintaining the confidentiality of your password which, together with your user identification, allows you to access certain LoanStreet Sites. Your user identification and password, together with other contact information, including business address, email addresses, and any bank account information, you provide comprise your "Registration Information".

If you become aware of any unauthorized use of your Registration Information, you agree to notify LoanStreet LLC immediately.

You agree that you will be responsible for any and all statements made, and acts or omissions that occur, through the use of your user identification and password. - g. Proper Use
 - i. No Unauthorized Use

ii. No Interference with Other Use & Enjoyment

You agree that you will not:

- 4. Decipher, decompile, disassemble, reverse-engineer or attempt to do any of the foregoing to any of the software comprising or in any way making up a part of any LoanStreet Site or LoanStreet Service.
 - iii. No Unlawful or Fraudulent Use

As a condition of your use of any LoanStreet Site or LoanStreet Service, you represent and warrant to, and agree with, LoanStreet LLC that you will not use any LoanStreet Site or LoanStreet Service for any purpose that is unlawful, fraudulent, in contravention of any other agreement or prohibited by this Agreement, or that could give rise to any civil or criminal liability.

iv. Conform to Federal, State and Local Banking Law & Regulations

You agree that you will not engage in any activities related to any LoanStreet Site or LoanStreet Service that are contrary to applicable laws or regulations, including any federal, state or local banking or lending law or regulations, including any consumer finance protection law or borrower personal privacy law.

v. No Securities Products

You agree that you will not engage in any activities related to any LoanStreet Site or LoanStreet Service that is contrary to any federal, state or local securities laws or regulations.

You agree not to use any LoanStreet Site or LoanStreet Service to offer to buy or sell or make a solicitation to buy or sell any "security", as that term is defined in the Securities Act of 1933.

You further agree that all purchases on any LoanStreet Site or through any LoanStreet Service shall be for investment purposes with no present intention of disposing of the investment and that no purchase shall be made on any LoanStreet Site or through any LoanStreet Service with a view to distribute that investment.

vi. No Marketing Other Products

You agree that you will not market or try to sell any of your or any third-party product or service through any LoanStreet Site or LoanStreet Service without the express written consent of LoanStreet LLC; provided, however, that this provision shall not inhibit your use of any LoanStreet Site or LoanStreet Service for its intended purposes, including entering into transactions for the sale of loans, loan assignments or loan participations.

- 5. Obligation to Conform to Applicable Law
 - a. Borrower Personal Information Privacy

You agree that you shall not use any LoanStreet Site or LoanStreet Service in a manner that violates any federal, state or local law governing any personal information of any borrower that is available through any LoanStreet Site or the subject of any LoanStreet Service. You shall strictly maintain the confidentiality of any personal information of any borrower to the extent it is available on any LoanStreet Site or LoanStreet Service, so long as it is confidential.

To the extent you are the party providing any borrower personal information, you shall redact or remove borrower personal information, to the extent required by any applicable law. LoanStreet LLC is not responsible for ensuring that you conform to applicable law.

b. Confidential Loan Information

In the event you review loan information on any LoanStreet Site or through any LoanStreet Service, you agree to be bound to the same confidentiality obligations of "co-lenders" set forth in the agreement governing purchases of loans, loan assignments and loan participations on any LoanStreet Site or through any LoanStreet Services with respect to each loan reviewed on any LoanStreet Site or through any LoanStreet Service whether or not a purchase is actually consummated.

c. Rights to Syndicate

You represent that to the extent you are using any LoanStreet Site or LoanStreet Service to sell, assign or participate any loan that you have the authority to do so and agree to make any required notices to the

borrower in a timely manner. LoanStreet LLC is not responsible for ensuring that you conform to applicable loan documents or applicable laws.

d. Right to Purchase

You represent that, to the extent you are using any LoanStreet Site or any LoanStreet Service to make a purchase of a loan, a loan assignment or a loan participation, you have the authority to do so and, to the extent you are, or are deemed to be, a co-lender under applicable agreements or applicable laws, that you are qualified to be a lender under any applicable banking, or lending law or regulation.

- 6. Information
 - a. Use of Information Services on LoanStreet Sites
